Dear Mr. Veljović,

Your request was only forwarded to me today. Otherwise I would have answered you sooner.

The insolvency debtor Promet has a claim from a court settlement less previous partial payments of €17,000 against Mr. Klaus Schneidereit - See Annex 1.

Mr. Schneidereit himself is insolvent; we have filed the claim in his insolvency proceedings (see Annex 2). The process is not over yet. I don't expect any more payments to be made. But we asked the insolvency administrator today. If I should receive different information, I will contact you.

We only processed this one claim against Mr. Schneidereit. In my view, the balance sheet approach to this claim should be written down to €1.

With the decision number St-370/2022 frome December 27th 2022 the Commercial court in Pazin (Croatia) appointed me as the temporary bankruptcy trustee of the company L.D.H. Promet d.o.o.. The court decision is attached to this e-mail.

My dutiy is to establish if L.D.H. Promet d.o.o. ha sany assets that are worth in order for the bankruptcy proceeding to continue, if there are existing reasons for the company to go through bankruptcy, or should the company be liquidated.

From the information that I received form mr. Sisic, L.D.H. Promet d.o.o. has an ongoing court proceeding in Germany with demand for payment. Form the balance sheet of L.D.H. Promet d.o.o. such amount is 128.614,24 euro.

I would therefore kindly ask you in for some information in order to complete my report that I need to file to the Commercial court in Pazin, namely:

- specification on the court proceeding (which court, who is the counterpart, what is the amount that L.D.H. Promet d.o.o. is demanding, and at what stage is the proceeding, and is there any possibility for L.D.H. Promet d.o.o. to receive any amount);
- what are the costs that L.D.H. Promet d.o.o. is facing continuing such court proceedings.

Also any other information that you deem useful will be appreciated.
