Abstract *Streptococcus pneumoniae* serotype 23vaccine (Pneumovax[®]) is recommended for all adults aged 65 years and older. The purpose of this study was to determine the impact of pneumococcal polysaccharide vaccine (PPV) on the incidence of invasive pneumococcal pneumonia in a community-based population. A retrospective cohort study was conducted in a community-based population of 10,000 residents of a large, urban, tertiary care hospital. The study population was divided into two groups: those who received PPV and those who did not. The incidence of invasive pneumococcal pneumonia was determined for each group. The incidence of invasive pneumococcal pneumonia was significantly lower in the vaccinated group compared to the unvaccinated group. The results of this study suggest that PPV is effective in reducing the incidence of invasive pneumococcal pneumonia in a community-based population.
