Prenositelj je društvu **PRIMOŠTEN d.d.**, sa sjedištem u Primošten (Općina Primošten), Raduča 11, Republika Hrvatska, OIB: 77587041388 (dalje u tekstu: „**Preuzimatelj**“) prenio gospodarsku cjelinu s učinkom od 1. srpnja 2023. temeljem ugovora o prijenosu gospodarske cjeline sklopljenog između Prenositelja i Preuzimatelja dana 27. lipnja 2023. (dalje u tekstu: „**Prijenos gospodarske cjeline**“).

U sklopu Prijenosa gospodarske cjeline, na Preuzimatelja je preneseno dospjelo i nepodmireno novčano potraživanje koje je utvrđeno i priznato u stečajnom postupku pod poslovnim brojem St-373/2020 (sada St-609/2024) pred Trgovačkim sudom u Splitu koji se vodi nad dužnikom **stečajna masa iza DURBAN d.o.o. u stečaju**, Murter (Općina Murter - Kornati), Ulica put Jersan 2, OIB: 01721182488 (dalje u tekstu: „**Dužnik**“), a koje ukupno iznosi **57.895,67 HRK**, odnosno **7.684,08 EUR** (konvertirano o fiksnom tečaju konverzije 1 EUR = 7,53450 HRK) (dalje u tekstu: „**Potraživanje**“).

STATEMENT on transfer of the receivable

As a part of the Business transfer, the overdue and outstanding monetary claim was transferred to the Transferee, which claim was determined and recognized in the bankruptcy proceedings under the business number St-373/2020 (now St-609/2024) before the Commercial Court in Split pending against the debtor **bankruptcy estate after DURBAN d.o.o. in bankruptcy**, Murter (Municipality Murter - Kornati), Ulica put Jersan 2, PIN: 01721182488 (hereinafter referred to as: „**Debtor**“), and which claim amounts to total of **HRK 57,895.67, i.e. EUR 7,684.08** (converted based on the fixed rate of 1 EUR = 7.53450 HRK) (hereinafter referred to as: „**Receivable**“).

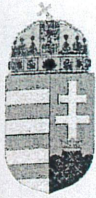
