Dana 12. veljače 2015. godine Trgovački sud u Zagrebu donio je Rješenje pod brojem Tt-14/29624 kojim je rješenjem utvrđen nastanak razloga za prestanak Društva te je izvršen upis u sudski registar koji je objavljnjen dana 13. veljače 2015. godine.

U skladu sa Zakonom o trgovačkim društvima pozvani su vjerovnici da prijave svoja potraživanja.

Ovim putem se potvrđuje da podjela imovine Društva između vjerovnika Društva i/ili članova Društva nije provedena.

Obzirom da je utvrđena nesposobnost Društva za plaćanje te da sukladno čl. 6. st. 2. On February 12<sup>th</sup>, 2015, the Commercial Court in Zagreb issued Decision No. Tt-14/29624, which determined the reasons for the termination of the Company and entered it in the court register which was published on February 13<sup>th</sup> 2015.

In accordance with the Companies Act, creditors were invited to report their claims.

It is hereby confirmed that the division of the Company's assets between the Company's creditors and / or Shareholders of the Company has not been executed.

Considering that the Company's inability to pay has been determined and that in accordance with Article 6 paragraph 2 of the Bankruptcy Act in the Register of the order of bases for payment kept by the Financial Agency the Company has several recorded unexecuted bases for payment in a period longer than 60 days which should have been paid, without further consent of the debtor, I hereby propose initiation and execution of bankruptcy procedure over the Company in accordance with article 132 of the Bankruptcy Act (OG 71/2015, 104/2017, 36/2022).
