I.

The Employer regularly gives notice to the Employee Christian Walter Bretterbauer, residing in Buje, Trg slobode 3, PIN: 10535338754 (hereinafter: Employee).

II.

The contract is cancelled due to the opening of bankruptcy proceedings against the Employer (business-related termination).

III.

This Decision shall be in force upon delivery.

EXPLANATION

On June 6th, 2025, based on the Decision of the Commercial Court in Pazin, case no. St-83/2025, bankruptcy proceedings were opened against the Employer.
