Upon court decision made by Commercial Court in Pazin, number St-83/2025 dated on 6th June 2025 (attached) I have been nominated as the bankruptcy manager in insolvency procedure over bankruptcy debtor GREEN GOLD BIO d.o.o. za trgovinu u stečaju, Caldanija 18, Caldanija, OIB (Croatian Vat number): 66129198657 (hereinafter referred as the **Bankruptcy debtor**).

In accordance to the claims of Your former attorney dated 25th of April 2025 I am hereby primary asking You to deliver, as follows:

- All associated company records

all within 8 days from the date of delivery this letter.

In the event that you do not comply with the above, I inform You that after the 8-day period has expired, I will begin to charge a fee for the use of a personal vehicle in the amount of 130,00 EUR per day (Insolvency Act - Article 216 paragraph 7).

In accordance to the previous statements, within the same scheduled period of 8 days, in order to deliver Written report on commercial status of Bankruptcy to the Commercial Court in Pazin, please deliver us the following documentation:

5. Employment contracts (present and former employees included), possible termination of aforementioned contracts together with obligations towards employees dated on 6th of June 2025
6. List of all obligations
7. List of all bank accounts (IBAN)
8. Confirmation from FINA regarding duration of insolvency period
9. List of all court litigations (both active and passive side) together with the lawyer contacts
10. List of all contracts
11. In case that Bankruptcy debtor has shares in other entities, all and any information for those entities.
12. Accounting person responsible contact
13. List of stamps
14. List of supplies
15. List of buyers and suppliers dated on 6th of June 2025.

Please notice that it is Your legal obligation to duly cooperate and provide with the aforementioned information (Insolvency Act - Article 180 and 177).
