zahvaljujemo na Vašem pojašnjenju. Smatramo kako bi javni bilježnik izdao rješenje o ovrsi na temelju vjerodostojne isprave, poput računa te ne bi inzistirao na osnovu potraživanja, poput ugovora. Međutim, radi temeljitosti, zatražit ćemo dodatnu dostupnu dokumentaciju koja potvrđuje postojanje tražbine prema Arduri d.o.o. Valja istaknuti da bi naplata tog potraživanja mogla dovesti do okončanja stečajnog postupka.

Gospodin Herzog je upoznat da društvo ARDURA d.o.o., Hrv. mornarice 1D, Split, OIB 21309493285 („**Ardura d.o.o.**”) duguje Stečajnom dužniku **91.530,25 EUR** po računu br. 1-1-1 od 31.12.2023. (73.224,20 EUR + PDV 18.306,05 EUR). Ističemo da je drugi član uprave i član društva Stečajnog dužnika, gospodin Johannes Matthias Erich Heuser, ujedno jedini član uprave i član društva Ardura d.o.o. Upravo je to razlog zašto je predmetno potraživanje još neplaćeno, premda je dospjelo prije skoro dvije godine.
