Dear Mr. Besek, thank You for sending the report.

The important thing is that the company JPM Services s.r.o. was deleted from the commercial register already on 21.05.2015, i.e. earlier than the date of your invoice, and merged with Santa Rosa s.r.o. This means that the legal successor of JPM Services s.r.o. is Santa Rosa s.r.o. And Santa Rosa Ltd. has also been dissolved and the successor company is Remeda Ltd. And Remeda s.r.o. is now bankrupt, which means that there is little realistic prospect of recovering the amount owed.

At the same time, I must inform you that JPM Services s.r.o. did not have its registered office in Račianska Street in Bratislava according to the Commercial Register.

In this case, the attorney's fee is EUR 250 for one act of legal service. This means that the amount for filing a lawsuit is 500 Eur and further according to the development of the case, but I cannot guarantee success.

Also, if you are interested in suing this company, you

need to provide a translation of the documents into Slovak, which I can help you with it.
