

Dear Mr. Magic,

I have received your request in which you invite me as the authorized person of Dalmacia Holiday d.o.o. to submit business documentation and company's property. I would like to inform you that I stopped being the authorized person of the company on December 8, 2020, and Mr. András Hegedűs was appointed as a new member of the Management Board, who remained a member of the Management Board until the bankruptcy procedure was opened. Since I have not come to the company's headquarters since my dismissal as a member of the Management Board, nor have I ever taken any business documentation or property out of the company, I urge you to contact the last member of the Management Board, Mr. Hegedűs, in order to obtain business documentation or company's property.

In relation to your request to pay the amount of HRK 29,535,326.00, which amount is the total amount of receivables that the company has against its debtors, according to your report from August 20, 2021, I inform you that such a request towards me is completely unfounded since I have no debts toward the company. I invite you to first determine to whom the company has that claims and continue to act in accordance with the powers given to you by the Bankruptcy Law.
