Dear Ms. Stasic,

may I ask you about the results of your last meeting with the creditors and how you intend to move forward.

As you know, the storage costs for all equipment are cumulating every month and you are refusing to pay these costs or to take-over the material.

An important part of the log yard system is stored in Croatia and causes almost 4000 EUR storage costs per month. We will not accept this any longer. The material is stored anyhow outside – as we have told you already – therefore there is no reason why it should not be stored outside at Cedar, Vrobovsko under the same storage conditions. The space of Cedar ground is far big enough to store this material.

This is economically necessary and will avoid ongoing storage costs.

We ask you to pick up the following material at HR-40305 Nedelišće **until latest 15<sup>th</sup> April 2025**:
