Dear Mr. Davorin Kapustić,

Thank you for your recent email regarding the alleged outstanding debt related to TVORNICA DUHANA UDBINA, currently in bankruptcy proceedings.

First and foremost, we acknowledge and respect your role as the appointed bankruptcy trustee and fully understand the importance of your duties in managing the estate's assets. We trust that your office seeks to conduct all proceedings with transparency and in accordance with both legal and commercial standards.

Following a thorough internal review of our records, we must respectfully dispute the amount claimed in your correspondence. We wish to point out the following:

1. The outstanding balance stated is not accurate, as it does not reflect the payments amounts, we have already made.
2. TVORNICA company failed to deliver a significant portion of the agreed services and they hold our materials, resulting in damage, direct financial losses and operational disruptions to our business.
3. These matters, including the actual outstanding amount, were previously acknowledged by TVORNICA and do not match the figures stated in your letter.

In light of these facts, we consider the current claim not only incorrect but also subject to potential counterclaims. We have tried to amicably through communication with Mr. Josip Mrvelj, but unfortunately, we did not receive any response, which we take as a lack of constructive engagement.

While we remain open to a fair and constructive resolution, we believe it is important to clarify both parties' positions through transparency and mutual respect.
