Good evening, first of all I understand your concern and feel well your anguish. Ranko is a good man and I am sure he knew nothing about this story. But he got into trouble through no fault of his own. First, I will tell you the case:

During the inspection of the Greek Customs (Evzones) 21 Chinese people without legal documents were found in his truck! The crime of smuggling is punished very severely by Greek law. Since there was no evidence against him, I was optimistic that a large money guarantee could be imposed and he could be released. However, the judicial investigator was very strict and decided to remand him in jail custody. This could last from 6 months to 18 months. The trial may take place in 2-3 years, however, the prisoner cannot remain in prison beyond this period and is released.

Regarding the case, there was no evidence against him in the criminal case file, since the transferred Chinese testified that they did not know him or have never seen him, nor did they give him any money. I don't have the decision yet, but I suspect that the main problem is that Ranko does not have a known declared permanent residence in Greece. That is why they were led to his temporary detention. Because at this process stage, the important thing is to ensure that the accused will be present at the trial. However, another restrictive condition could be imposed, e.g. a ban on leaving the country, but Ranko does not have a permanent and legal residence in Greece.

I will challenge this decision through an appeal, which will be examined by a Council of several judges to decide if there are reasons to remain in prison or whether he will be released. For this I need:

- **The Tax declaration** (a document for showing Ranko's annual income, that he had no financial need to be paid to transport foreigners illegally).

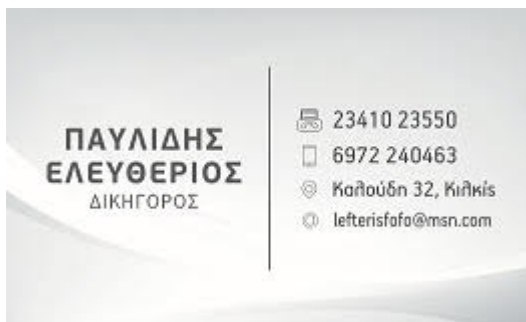
- **Certificate of residence Municipality** (the officially declared residential address in Ladimirevci).
- **Certificate of family status** (wife and 3 children).
- **Medical Certificate of his disease/health** (diabetes).

You must send me all of this translated into Greek as soon as possible, because we only have 10 days!!!

I hope everything goes well, I will do my best. However, no one can guarantee if the Judicial Council will accept our appeal, it usually rejects them, but I believe we must exhaust all possibilities. It's cruel to keep an innocent person in prison for 6 months.

Anyway, we will be in mail communication. My phone number is below, anything you need you can ask me. But please do it quickly because we don't have much time and these documents are valuable! **On Friday, December 13th, I will file the appeal so I need to have all the documents in my hands by then.** Regarding the legal costs, the best price I can give is 400€.
