A review of the receivables in the balance sheet of the company EES DRAVACEL ENERGETIKA d.o.o. in bankruptcy for NORTH TECH DRILLING ehf, Laugarasvegur 13 104, Reykjavik, Iceland, has determined an unfulfilled obligation of this company towards the company EES DRAVACEL ENERGETIKA d.o.o., in connection with the loan agreement dated 19.01.2024. in the amount of EUR 258,815.00.

The loan agreement was signed by Ishiat Ahmad, director of EES DRAVACEL ENERGETIKA d.o.o. and Lars Ingar Gulstrand, director of CINDRIGO LTD. The loan agreement contains an explicit instruction that the amount in question be paid by Cindrigo directly to the company North Tech Drilling ehf from Reykjavik. There is no information in the accounting documentation, nor any documents that the company North Tech Drilling ehf did anything in 2024. for the company EES Dravacel Energetika d.o.o., so the debtor North Tech Drilling ehf should return the money to the creditor EES Dravacel Energetika d.o.o. in bankruptcy.

What work did the company North Tech Drilling ehf perform and what work should it have performed for the company EES Dravacel Energetika d.o.o. for the amount of EUR 258,815.00? If your company performed certain work in 2024.g. in connection with the paid work for the amount of EUR 258,815.00, please send me the contract and invoices regarding the work performed, and documents certified by EES Dravacel Energetika doo for the service or work performed.

If you have not done anything, please return money in the amount of EUR 258. 815.00 by 31.02.2026 to the account of EES Dravacel Energetika do.o. in bankruptcy IBAN: HR6023600001103173888 , Zagrebačka banka , Zagreb, Croatia . If you do not return money by 31.02.2026, we will initiate a lawsuit to collect the claims of EES Dravacel Energetika doo in bankruptcy against North Tech Drilling ehf.
