**ORDER GRANTING DEBTOR'S MOTION FOR ENTRY**  
**OF ORDER MODIFYING THE AUTOMATIC STAY<sup>1</sup>**

**THIS MATTER** came before the Court for hearing on February 23, 2023, at 11:30 a.m. via video conference on the Motion for Entry of Order Modifying the Automatic Stay (the "Motion") [ECF No. 19] filed by Adria MM Productions, Ltd ("AMM" or "Debtor"), through Jelena Kordič, its qualified Foreign Representative, and the Court, having reviewed the Motion and the Response to Debtor's Motion for Entry of Order Modifying the Automatic Stay [ECF No. 25] filed by Worldwide Entertainment Group, Inc., heard argument of counsel, and being

otherwise duly advised in the premises, and for the reasons stated on the record which are incorporated herein by reference, it is –

**ORDERED and ADJUDGED** that:

1. The Motion is **GRANTED**.
2. The automatic stay authorized by section 1520(a)(1) of the Bankruptcy Code pursuant to the Recognition Order is hereby modified to allow *Adria MM Productions, Ltd. v. Worldwide Entertainment Group, Inc.*, Case Nos. 19-11052-J and 19-12056 (the “Appeal”),<sup>2</sup> currently pending in the United States Court of Appeal for the Eleventh Circuit (the “Eleventh Circuit”), to proceed to final resolution of all issues, including by motion, which may be raised in the appellate court by all parties.
3. The 14-day period prescribed by Federal Rule of Bankruptcy Procedure 4001(a)(3) is waived.
4. The Court shall retain jurisdiction to hear and determine all matters arising from or related to the interpretation and enforcement of this Order.

Hello. The bankruptcy court entered the attached order modifying the automatic stay to allow the appeal to proceed. **AGREED ORDER OF REFERRAL TO THE HONORABLE JUDGE  
PAUL G. HYMAN TO HOLD A SETTLEMENT CONFERENCE**

THIS MATTER came before the Court on February 23, 2023, at 11:30 a.m. via Zoom video conference, upon an *ore tenus* motion by Worldwide Entertainment Group, Inc. (“Worldwide”), as party-in-interest and creditor of Adria MM Productions, Ltd. (“Debtor”), to refer all claims and related disputes between and among the Debtor and creditors Worldwide, Kozyak Tropin Throckmorton LLP (“KTT”), and Rubinstein Law<sup>1</sup> (collectively, the “Parties”) to

the Honorable Judge Paul G. Hyman to hold a settlement conference to seek to resolve all such claims and disputes. The Court, pursuant to Local Rule 9019-2, having considered the motion and the discussion of the respective counsel for the Debtor, Worldwide, and KTT at the hearing, noting that no objection to the requested referral was asserted, and being otherwise duly advised in the premises, hereby **ORDERS** as follows:

1. All claims and related disputes between and among the Parties are referred to the Honorable Paul G. Hyman to hold a settlement conference. The Parties are required to participate in this judicial settlement conference and may appear by video conference.

2. The Parties have agreed to Judge Hyman's conducting the settlement conference, and, as such, need not indicate their selection of a mediator by filing the Local Form Notice of Selection of Mediator.

3. Upon consultation with the Parties and their respective counsel, Judge Hyman shall fix a reasonable time and place for the settlement conference, permitting appearance by video conference, no later than June 2, 2023, except as otherwise agreed by the parties or by order of the Court, and shall give the Parties at least 14 days advance written notice of the conference.

4. The appearance of counsel and representatives of the Parties with full authority to enter into full and complete compromise and settlement is mandatory.

5. Judge Hyman may report to the Court the complete failure of any party to attend the mediation conference, which failure may result in the imposition of sanctions by the Court.

6. There will be no cost to the Parties to have Judge Hyman conduct the settlement conference, however, there may be other costs associated with the conference, which shall be shared equally by the Parties.

7. Notice to Judge Hyman of cancellation or settlement prior to the scheduled mediation conference must be given at least two full business days in advance.

8. Within seven days after the settlement conference, Judge Hyman shall file the Local Form Report of Mediator required by Local Rule 9019-2(E). In the event there is an impasse, Judge Hyman shall report that there is a lack of agreement, with no further comment or recommendation.

9. If the Parties have reached an agreement regarding the disposition of the claims and related disputes, they shall prepare and submit to the Court within 14 days after the filing of the Report of Mediator an appropriate stipulation of settlement and joint motion for its approval. Failure to file such a motion shall be a basis for the court to impose appropriate sanctions.

Sud je, u skladu s lokalnim pravilom 9019-2, razmotrio prijedlog i raspravu dotičnog odvjetnika dužnika, Worldwida i KTT-a na ročištu, napominjući da nije uloženi nikakav prigovor na zatraženo upućivanje, a niti inače je propisno obaviješten u prostorijama, ovim NALAŽE kako slijedi:

1. Sva potraživanja i povezani sporovi među i između strana upućuju se uvaženom sudcu Paulu G. Hymanu na održavanje konferencije o nagodbi. Stranke su dužne sudjelovati na ovoj konferenciji o sudskoj nagodbi i mogu se pojaviti putem video konferencije.

2. Strane su se složile da sudac Hyman vodi konferenciju o nagodbi i, kao takve, ne moraju naznačiti svoj odabir medijatora podnošenjem lokalnog obrasca Obavijest o odabiru medijatora.

3. Nakon konzultacija sa strankama i njihovim odgovarajućim odvjetnicima, sudac Hyman odredit će razumno vrijeme i mjesto za konferenciju o nagodbi, dopuštajući pojavljivanje putem video konferencije, najkasnije do 2. lipnja 2023., osim ako se strane drugačije dogovore ili nalogom Suda, te će strankama dati pismenu obavijest o konferenciji najmanje 14 dana unaprijed.

4. Obavezno je pojavljivanje savjetnika i predstavnika stranaka s punim ovlaštenjima za sklapanje punog i potpunog kompromisa i nagodbe.

5. Sudac Hyman može prijaviti Sudu potpuni propust bilo koje strane da prisustvuje medijacijskoj konferenciji, a taj propust može rezultirati izricanjem sankcija od strane Suda.

6. Neće biti troškova za stranke da sudac Hyman vodi konferenciju o nagodbi, međutim, mogu postojati drugi troškovi povezani s konferencijom, koje će strane ravnomjerno podijeliti.

9. Ako su stranke postigle sporazum o raspolaganju potraživanjima i povezanim sporovima, dužne su u roku od 14 dana od podnošenja Izvješća medijatora pripremiti i dostaviti Sudu odgovarajuću odredbu o nagodbi i zajednički prijedlog za njezino odobrenje. Nepodnošenje takvog prijedloga bit će temelj da sud izrekne odgovarajuće sankcije.

Hi Tom. The court has now entered the order of referral for the judicial settlement conference, it is attached. In terms of the settlement conference, Adria is not required to enter into a settlement agreement, only attend in a good faith effort to resolve the matters with WEG (and the attorneys' liens). So the goal of the conference is to see if another neutral party—Judge Hyman—can help the parties resolve the current appeal without having to litigate the appeal before the appellate court. The benefit to this is if the conference is successful then the matter is resolved now and there is no additional time or cost for an appeal. Obviously, it would seem that Adria would only enter into a settlement where WEG pays Adria money given the nature of the judgments previously entered. The question will be how much money will WEG be willing to pay to resolve this matter. I do not see any downside to participating in this settlement conference, except the time to attend and attorneys' fees. Judge Hyman typically schedules his conferences to be completed in one day (sometimes they are completed in a few hours and sometimes they take the whole day). We are checking on Judge Hyman's availability and will let you know. Hopefully the conference can occur within 30-45 days.

I am not sure what documents will be needed at this time. Judge Hyman normally requires a written statement outlining a party's position and any documents which would support that position. Here, hopefully most of the relevant documents have already been filed with the trial court in the WEG matter or are part of the record on appeal and Jelena will not have to look for additional documents.

Please let me know if this answers your questions or if you have any additional questions.

Hello. We are still trying to coordinate a date with the Judge to conduct the settlement conference. The Judge's calendar has been busier than normal because he has taken on some assignments for one of the other judges that recently retired. I will let you know as soon as I have a date.

If an agreement is reached at the judicial settlement conference which results in money being paid to AMM, then the money should be able to be paid fairly quickly (30 days or so) given that there is a bond posted to cover the amount of the underlying judgment. AMM will have to address any claims of attorneys to the money, but that should be discussed and hopefully resolved at the judicial settlement conference. If nothing is resolved at the judicial settlement conference, then the parties will continue to litigate the appeal of the underlying judgments. I am not sure of the status of the appeal or any deadlines in that case, so maybe Carolyn can update us.
