Training rewards trigger generating the Electronic Player Passport (cf. articles 5, 6, 7 and 8 FCHR)

1. The training rewards trigger identified for the generation of the Electronic Player Passport (EPP) consisted of an international transfer against payments of a player before the end of the calendar year of the player's 23rd birthday (cf. article 6 FCHR).
2. The payments are conditional payments only.
3. The EPP 43225 was duly generated upon the identification of the above trigger(s), as per article 8 paragraph 1 of the FCHR.
4. According to the relevant provisions of the RSTP, the following training reward(s) may be due in the context of the above trigger:

Training compensation: in case of an international transfer of a male professional between clubs of two different associations (whether during or at the end of the player's contract) before the end of the calendar year of the player's 23rd birthday, training compensation is owed to the player's former club for the time the player was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP);

Solidarity contribution: in case of an international transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12th birthday of the player until the end of the calendar year of the 23rd birthday of the player (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP);

EPP review process (cf. articles 8 and 9 FCHR)

5. Upon completion of the inspection period related to the abovementioned EPP, the parties to the EPP were invited to participate in the EPP review process.
6. The EPP review process permitted the participating member associations to provide all relevant registration information of the player and the participating clubs to provide all documentation relevant to their entitlement to training rewards, in accordance with articles 8 and 9 of the FCHR.
7. The following parties participated in the EPP review process:
 - a) Football Association of Slovenia (NZS)
 - b) Croatian Football Federation (HNS)
 - c) Nogometni/Fudbalski Savez Bosne i Hercegovine (FFBH)

- d) HNK Hajduk, HNS
- e) FK VELEŽ, FFBH

- g) GNK Dinamo, HNS
- h) NK Istra 1961, HNS
- i) HŠK POSUŠJE, FFBH
- j) FC Koper, NZS

Determination of the FIFA general secretariat on EPP 43225 (cf. article 10 FCHR)

8. The FIFA general secretariat hereby determines the registration history of the player from the start of the calendar year of the player's 12th birthday until the aforementioned training rewards trigger. This registration history is considered true and accurate for the period in question, in accordance with the information provided by the member associations that participated in the generation and review of the EPP, in accordance with article 10 of the FCHR. The registration history as determined by the FIFA general secretariat is as follows:

Considerations for entitlement to training rewards (cf. article 10 FCHR)

9. For the purpose of distribution of training rewards, the FIFA general secretariat makes the following determinations in consideration of the documents and information provided by the parties within the EPP review process.
10. **Registration with club HNK Hajduk (HNS) between 4 July 2024 and 7 July 2024, 27 June 2023 and 15 January 2024, 25 January 2023 and 21 February 2023, 8 July 2022 and 14 July 2022, 16 August 2017 and 4 July 2021, 1 January 2013 and 13 August 2015:**
Training Compensation
 - 10.1. In case of an international transfer of a professional between clubs of two different associations (whether during or at the end of his contract) before the end of the calendar year of his 23rd birthday, training compensation is owed to his former club for the time he was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP) from the calendar year of his 12th birthday up until the end of the calendar year of his 21st birthday (cf. article 1 paragraph 1 of Annexe 4 and article 5 paragraph 2 of Annexe 4 to the RSTP).
 - 10.2. The player was registered with HNK Hajduk as a professional before the end of the calendar year of his 21st birthday before being registered as a professional with FK VELEŽ before the end of the calendar year of his 23rd birthday.
 - 10.3. HNK Hajduk is therefore in principle entitled to training compensation.
 - 10.4. However, as established by the jurisprudence of the Dispute Resolution Chamber, in case of an international transfer of a player between two clubs affiliated to different member associations (before and/or after the end of the calendar year of the 23rd birthday of the player) against compensation, it is considered that any training compensation that may be due to the former club is deemed to be included in the said compensation unless the parties agreed to unequivocally exclude it from the transfer compensation.

- 10.5. The transfer agreement in relation to the training reward trigger of reference signed between HNK Hajduk. and FK VELEŽ does not contain any specific clause vis-à-vis the exclusion of the potential training compensation entitlement of HNK Hajduk from the transfer compensation.
- 10.6. In view of the above, it is determined that the terms contained in the transfer agreement are valid and binding, and any potential training compensation due to HNK Hajduk in relation to the transfer of reference is included in the transfer compensation.

Solidarity Contribution

- 10.7. The player inter alia was registered with HNK Hajduk between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 10.8. HNK Hajduk is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

11. Registration with club FC Koper (NZS) between 1 July 2024 and 2 July 2024, 30 January 2024 and 30 June 2024:

Training Compensation

- 11.1. According to articles 1 and 5 of Annexe 4 to the RSTP, training compensation is payable to the training club(s) of the player for training and education provided to a player up until the end of the calendar year of his 21st birthday.
- 11.2. The player was registered with FC Koper after the end of the calendar year of his 21st birthday.
- 11.3. FC Koper is therefore not entitled to training compensation for the registration of the player at the club during the aforementioned period(s).

Solidarity Contribution

- 11.4. The player inter alia was registered with FC Koper between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 11.5. FC Koper is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

12. Registration with club NK Istra 1961 (HNS) between 20 July 2022 and 23 January 2023:

Training Compensation

- 12.1. In case of an international transfer of a professional between clubs of two different associations (whether during or at the end of his contract) before the end of the calendar year of his 23rd birthday, training compensation is owed to his former club for the time he was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP) from the calendar year of his 12th birthday up until the end of the calendar year

of his 21st birthday (cf. article 1 paragraph 1 of Annexe 4 and article 5 paragraph 2 of Annexe 4 to the RSTP).

- 12.2. NK Istra 1961 is not the former club of the player in the sense of the aforementioned provisions.
- 12.3. However, as established by the jurisprudence of the Dispute Resolution Chamber, when a player registers with a club affiliated to a different member association (i.e. the new club) from the one where he was previously registered (i.e. the former club), any club(s) that may have had the player directly on loan from the player's former club should be entitled to training compensation from the new club.
- 12.4. The player was registered with NK Istra 1961 as a professional directly on loan from the former club before being subsequently registered as a professional with FK VELEŽ before the end of the calendar year of his 23rd birthday.
- 12.5. NK Istra 1961 is therefore entitled to training compensation for the registration of the player at the club between 20 July 2022 and 31 December 2022.

Solidarity Contribution

- 12.6. The player inter alia was registered with NK Istra 1961 between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 12.7. NK Istra 1961 is therefore entitled to solidarity contribution for the registration of the player at the club between 20 July 2022 and 23 January 2023.

13. Registration with club HŠK POSUŠJE (FFBH) between 9 July 2021 and 7 July 2022:

Training Compensation

- 13.1. In case of an international transfer of a professional between clubs of two different associations (whether during or at the end of his contract) before the end of the calendar year of his 23rd birthday, training compensation is owed to his former club for the time he was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP) from the calendar year of his 12th birthday up until the end of the calendar year of his 21st birthday (cf. article 1 paragraph 1 of Annexe 4 and article 5 paragraph 2 of Annexe 4 to the RSTP).
- 13.2. HŠK POSUŠJE is not the former club of the player in the sense of the aforementioned provisions.
- 13.3. However, as established by the jurisprudence of the Dispute Resolution Chamber, when a player registers with a club affiliated to a different member association (i.e. the new club) from the one where he was previously registered (i.e. the former club), any club(s) that may have had the player directly on loan from the player's former club should be entitled to training compensation from the new club.

13.4. The player was registered with HŠK POSUŠJE as a professional directly on loan from the former club before being subsequently registered as a professional with FK VELEŽ before the end of the calendar year of his 23rd birthday.

13.5. HŠK POSUŠJE is therefore entitled to training compensation for the registration of the player at the club during the relevant periods mentioned.

Solidarity Contribution

13.6. The player inter alia was registered with HŠK POSUŠJE between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

13.7. HŠK POSUŠJE is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

14. Registration with club GNK Dinamo (HNS) between 24 August 2016 and 9 August 2017:

Training Compensation

14.1. In case of an international transfer of a professional between clubs of two different associations (whether during or at the end of his contract) before the end of the calendar year of his 23rd birthday, training compensation is owed to his former club for the time he was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP).

14.2. GNK Dinamo is not the former club of the player in the sense of the aforementioned provisions.

14.3. GNK Dinamo is therefore not entitled to training compensation for the registration of the player at the club during the relevant periods mentioned.

Solidarity Contribution

14.4. The player inter alia was registered with GNK Dinamo between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

14.5. GNK Dinamo is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

15. Registration with club RNK Split (HNS) between 2 September 2015 and 23 June 2016:

Training Compensation

15.1. In case of an international transfer of a professional between clubs of two different associations (whether during or at the end of his contract) before the end of the calendar year of his 23rd birthday, training compensation is owed to his former club for the time he was effectively trained by that club (cf. article 2 paragraph 1 b) of Annexe 4 and article 3 paragraph 1 of Annexe 4 to the RSTP).

- 15.2. RNK Split is not the former club of the player in the sense of the aforementioned provisions.
- 15.3. RNK Split is therefore not entitled to training compensation for the registration of the player at the club during the relevant periods mentioned.

Solidarity Contribution

- 15.4. The player inter alia was registered with RNK Split between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 15.5. RNK Split is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).




Conclusion

16. In consideration of the above and in accordance with the FCHR and annexes 4 and 5 to the RSTP, the FIFA general secretariat has determined the entitlement of clubs to training rewards for the above trigger as follows.
17. HNK Hajduk would in principle be entitled to training compensation for having registered the player at some point in time between the start of the calendar year of player's 12th birthday and the end of the calendar year of player's 21st birthday, but given that training compensation is deemed included in the transfer fee paid by the new club, no training compensation is due to this training club.
18. NK Istra 1961 is entitled to training compensation for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 21st birthday.
19. HŠK POSUŠJE is entitled to training compensation for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 21st birthday.
20. No other club is entitled to training compensation.
21. HNK Hajduk is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
22. FC Koper is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
23. NK Istra 1961 is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
24. HŠK POSUŠJE is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
25. GNK Dinamo is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
26. RNK Split is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
27. No other club is entitled to solidarity contribution.

28. All of the above determinations and decisions are reflected in the EPP in question and/or will be considered in the generation of any Allocation Statement from this EPP for the calculation and distribution of training rewards in accordance with article 13 of the FCHR.
29. More specifically, in case of an international transfer (cf. article 6 FCHR) with payments, this EPP will be considered in the generation of any future Allocation Statement for the calculation and distribution of any solidarity contribution that may become due at a later stage if and when the payments requirements are met.
30. Pursuant to article 57 paragraph 1 of the FIFA Statutes and in accordance with article 10 of the FCHR, this decision and the corresponding allocation statements AS TC-11641 may be jointly appealed before the Court of Arbitration for Sport within 21 days of notification. The final EPP will remain available in TMS.
