Training rewards trigger generating the Electronic Player Passport (cf. articles 5, 6, 7 and 8 FCHR)

1. The training rewards trigger identified for the generation of the Electronic Player Passport (EPP) consisted of an international transfer against payments of a player after the end of the calendar year of the player's 23rd birthday (cf. article 6 FCHR).
2. The payments are conditional payments only.
3. The EPP 43778 was duly generated upon the identification of the above trigger(s), as per article 8 paragraph 1 of the FCHR.
4. According to the relevant provisions of the RSTP, the following training reward(s) may be due in the context of the above trigger:

Solidarity contribution: in case of an international transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12th birthday of the player until the end of the calendar year of the 23rd birthday of the player (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP);

EPP review process (cf. articles 8 and 9 FCHR)

5. Upon completion of the inspection period related to the abovementioned EPP, the parties to the EPP were invited to participate in the EPP review process.
6. The EPP review process permitted the participating member associations to provide all relevant registration information of the player and the participating clubs to provide all documentation relevant to their entitlement to training rewards, in accordance with articles 8 and 9 of the FCHR.
7. The following parties participated in the EPP review process:
 - a) ATALANTA BERGAMASCA C.SRL, FIGC
 - b) NK Osijek, HNS
 - c) HELLAS VERONA F.C. S.P.A., FIGC
 - d) RNK Split, HNS
 - e) R. STANDARD DE LIEGE, BEL
 - f) GNK Dinamo, HNS

- g) Federazione Italiana Giuoco Calcio (FIGC)
- h) Croatian Football Federation (HNS)
- i) Union Royale Belge des Sociétés de Football-Association (BEL)

Determination of the FIFA general secretariat on EPP 43778 (cf. article 10 FCHR)

8. The FIFA general secretariat hereby determines the registration history of the player from the start of the calendar year of the player's 12th birthday until the aforementioned training rewards trigger. This registration history is considered true and accurate for the period in question, in accordance with the information provided by the member associations that participated in the generation and review of the EPP, in accordance with article 10 of the FCHR. The registration history as determined by the FIFA general secretariat is as follows:

Considerations for entitlement to training rewards (cf. article 10 FCHR)

9. For the purpose of distribution of training rewards, the FIFA general secretariat makes the following determinations in consideration of the documents and information provided by the parties within the EPP review process.
10. **Registration with club GNK Dinamo (HNS) between 5 July 2022 and 5 July 2024:**
 - 10.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 10.2. The player inter alia was registered with GNK Dinamo between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
 - 10.3. GNK Dinamo is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

- 11. Registration with club HELLAS VERONA F.C. S.P.A. (FIGC) between 25 August 2021 and 30 June 2022:**
 - 11.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 11.2. The player inter alia was registered with HELLAS VERONA F.C. S.P.A. between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
 - 11.3. HELLAS VERONA F.C. S.P.A. is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 12. Registration with club ATALANTA BERGAMASCA C.SRL (FIGC) between 31 January 2020 and 31 August 2020, 1 September 2020 and 30 June 2021, 1 July 2021 and 24 August 2021:**
 - 12.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 12.2. The player inter alia was registered with ATALANTA BERGAMASCA C.SRL between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
 - 12.3. ATALANTA BERGAMASCA C.SRL is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 13. Registration with club NK Osijek (HNS) between 2 August 2017 and 30 January 2020:**
 - 13.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 13.2. The player inter alia was registered with NK Osijek between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
 - 13.3. NK Osijek is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 14. Registration with club RNK Split (HNS) between 2 September 2015 and 28 July 2017:**
 - 14.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 14.2. The player inter alia was registered with RNK Split between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

- 14.3. RNK Split is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
15. **Registration with club NK Neretva - u stečaju (HNS) between 1 January 2012 and 3 August 2015:**
 - 15.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 15.2. The player inter alia was registered with NK Neretva - u stečaju between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
 - 15.3. The member association HNS confirmed that the club NK Neretva - u stečaju is no longer affiliated to the HNS and ceased to participate in organised football.
 - 15.4. A member association may receive training rewards that should have been distributed to a training club if the said club has in the meantime ceased to participate in organised football and/or no longer exists due to, in particular, bankruptcy, liquidation, dissolution or loss of affiliation. This compensation shall be reserved for youth football development programmes in the association(s) in question (cf. art. 3 par. 3 of Annexe 4 RSTP and art. 2 par. 3 of Annexe 5 RSTP).
 - 15.5. In consideration of the above, the FIFA general secretariat determines that HNS is therefore entitled to solidarity contribution for the registration of the player at the disaffiliated club NK Neretva - u stečaju during the aforementioned period(s).

Conclusion

16. In consideration of the above and in accordance with the FCHR and annexes 4 and 5 to the RSTP, the FIFA general secretariat has determined the entitlement of clubs to training rewards for the above trigger as follows.
17. GNK Dinamo is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
18. HELLAS VERONA F.C. S.P.A. is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
19. ATALANTA BERGAMASCA C.SRL is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
20. NK Osijek is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
21. RNK Split is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
22. HNS is entitled to solidarity contribution for the time that the player was registered with the disaffiliated club NK Neretva - u stečaju at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
23. All of the above determinations and decisions are reflected in the EPP in question and/or will be considered in the generation of any Allocation Statement from this EPP for the calculation and distribution of training rewards in accordance with article 13 of the FCHR.
24. More specifically, in case of an international transfer (cf. article 6 FCHR) with payments, this EPP will be considered in the generation of any future Allocation Statement for the calculation and distribution of any solidarity contribution that may become due at a later stage if and when the payments requirements are met.

25. Pursuant to article 57 paragraph 1 of the FIFA Statutes and in accordance with article 10 of the FCHR, this decision may be appealed before the Court of Arbitration for Sport within 21 days of notification. The final EPP will remain available in TMS.
