Training rewards trigger generating the Electronic Player Passport (cf. articles 5, 6, 7 and 8 FCHR)

1. The training rewards trigger identified for the generation of the Electronic Player Passport (EPP) consisted of national transfer involving transfer compensation (cf. article 7 FCHR).
2. The payments are conditional payments only.
3. The EPP 38519 was duly generated upon the identification of the above trigger(s), as per article 8 paragraph 1 of the FCHR.
4. According to the relevant provisions of the RSTP, the following training reward(s) may be due in the context of the above trigger:

Solidarity contribution: in case of a national transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12th birthday of the player until the end of the calendar year of the 23rd birthday of the player, given that the said training clubs are affiliated to a different association than the association(s) of the former club and the new club (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP).

EPP review process (cf. articles 8 and 9 FCHR)

5. Upon completion of the inspection period related to the abovementioned EPP, the parties to the EPP were invited to participate in the EPP review process.
6. The EPP review process permitted the participating member associations to provide all relevant registration information of the player and the participating clubs to provide all documentation relevant to their entitlement to training rewards, in accordance with articles 8 and 9 of the FCHR.
7. The following parties participated in the EPP review process:
 - a) Deutscher Fussball-Bund (DFB);
 - b) Croatian Football Federation (HNS);
 - c) NK Lokomotiva (Z), HNS;
 - d) Eintracht Frankfurt, DFB;
 - e) NK Imotski, HNS;
 - f) FC Augsburg, DFB;
 - g) RNK Split, HNS;

- h) GNK Dinamo, HNS;
- i) NK Istra 1961, HNS;
- j) NK Mračaj, represented by its member association HNS.

Determination of the FIFA general secretariat on EPP 38519 (cf. article 10 FCHR)

8. The FIFA general secretariat hereby determines the registration history of the player from the start of the calendar year of the player's 12th birthday until the aforementioned training rewards trigger. This registration history is considered true and accurate for the period in question, in accordance with the information provided by the member associations that participated in the generation and review of the EPP, in accordance with article 10 of the FCHR. The registration history as determined by the FIFA general secretariat is as follows:

Considerations for entitlement to training rewards (cf. article 10 FCHR)

9. For the purpose of distribution of training rewards, the FIFA general secretariat makes the following determinations in consideration of the documents and information provided by the parties within the EPP review process.
10. **Registration with club Eintracht Frankfurt (DFB) between 1 July 2022 and 18 January 2024, 30 August 2021 and 30 June 2022:**
 - 10.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
 - 10.2. The player was registered with Eintracht Frankfurt after the end of the calendar year of his 23rd birthday.

10.3. According to article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP, a training club is entitled to receive solidarity contribution in case a professional player is transferred against payment, either on a definitive or loan basis, between clubs affiliated to the same association, provided that the training club is affiliated to a different association.

10.4. Eintracht Frankfurt and FC Augsburg are both affiliated to the DFB.

10.5. Therefore, Eintracht Frankfurt is not entitled to solidarity contribution.

11. Registration with club GNK Dinamo (HNS) between 12 August 2020 and 29 August 2021:

11.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.

11.2. The player *inter alia* was registered with GNK Dinamo between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

11.3. GNK Dinamo is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

12. Registration with club NK Lokomotiva (Z) (HNS) between 20 June 2018 and 10 August 2020, 5 July 2017 and 4 February 2018:

12.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.

12.2. The player *inter alia* was registered with NK Lokomotiva (Z) between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

12.3. NK Lokomotiva (Z) is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

13. Registration with club NK Istra 1961 (HNS) between 7 February 2018 and 15 June 2018:

13.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.

13.2. The player *inter alia* was registered with NK Istra 1961 between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

13.3. NK Istra 1961 is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

14. Registration with club RNK Split (HNS) between 21 August 2013 and 14 May 2017:

- 14.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
- 14.2. The player inter alia was registered with RNK Split between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 14.3. RNK Split is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

15. Registration with club NK Imotski (HNS) between 12 August 2009 and 9 July 2013:

- 15.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
- 15.2. The player inter alia was registered with NK Imotski between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 15.3. NK Imotski is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

16. Registration with club NK Mračaj (HNS) between 1 January 2009 and 3 August 2009:


- 16.1. According to article 1 of Annexe 5 to the RSTP, solidarity contribution is payable to the training club(s) for training and education provided to a player up until the end of the calendar year of the player's 23rd birthday.
- 16.2. The player inter alia was registered with NK Mračaj between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 16.3. NK Mračaj is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

Conclusion

- 17. In consideration of the above and in accordance with the FCHR and annexes 4 and 5 to the RSTP, the FIFA general secretariat has determined the entitlement of clubs to training rewards for the above trigger as follows.
- 18. GNK Dinamo is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.

19. NK Lokomotiva (Z) is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
20. NK Istra 1961 is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
21. RNK Split is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
22. NK Imotski is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
23. NK Mračaj is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
24. No other club is entitled to solidarity contribution.
25. All of the above determinations and decisions are reflected in the EPP in question and/or will be considered in the generation of any Allocation Statement from this EPP for the calculation and distribution of training rewards in accordance with article 13 of the FCHR.
26. More specifically, in case of a national transfer (cf. article 7 FCHR) with payments, this EPP will be considered in the generation of any future Allocation Statement for the calculation and distribution of any solidarity contribution that may become due at a later stage if and when the payments requirements are met.
27. Pursuant to article 57 paragraph 1 of the FIFA Statutes and in accordance with article 10 of the FCHR, this decision may be appealed before the Court of Arbitration for Sport within 21 days of notification. The final EPP will remain available in TMS.
