## Training rewards trigger generating the Electronic Player Passport (cf. articles 5, 6, 7 and 8 FCHR)

1. The training rewards trigger identified for the generation of the Electronic Player Passport (EPP) consisted of an international transfer against payments of a player after the end of the calendar year of the player's 23rd birthday (cf. article 6 FCHR).
2. The payments are conditional payments only.
3. The EPP 45973 was duly generated upon the identification of the above trigger(s), as per article 8 paragraph 1 of the FCHR.
4. According to the relevant provisions of the RSTP, the following training reward(s) may be due in the context of the above trigger:

**Solidarity contribution:** in case of an international transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12<sup>th</sup> birthday of the player until the end of the calendar year of the 23<sup>rd</sup> birthday of the player (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP);

## EPP review process (cf. articles 8 and 9 FCHR)

5. Upon completion of the inspection period related to the abovementioned EPP, the parties to the EPP were invited to participate in the EPP review process.
6. The EPP review process permitted the participating member associations to provide all relevant registration information of the player and the participating clubs to provide all documentation relevant to their entitlement to training rewards, in accordance with articles 8 and 9 of the FCHR.
7. The following parties participated in the EPP review process:

8. #### Considerations for entitlement to training rewards (cf. article 10 FCHR)

9. For the purpose of distribution of training rewards, the FIFA general secretariat makes the following determinations in consideration of the documents and information provided by the parties within the EPP review process.
10. **Registration with club Real Racing Club de Santander SAD (RFEF) between 3 February 2023 and 30 June 2023:**
  - 10.1. The player inter alia was registered with Real Racing Club de Santander SAD between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 10.2. Real Racing Club de Santander SAD is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

- 11. Registration with club Gil Vicente FC (FPF) between 21 July 2023 and 31 December 2023:**
  - 11.1. The player inter alia was registered with Gil Vicente FC between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 11.2. Gil Vicente FC is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 12. Registration with club FERENCVÁROSI TORNA CLUB (MLSZ) between 3 July 2023 and 20 July 2023, 31 January 2023 and 31 January 2023, 19 January 2022 and 22 June 2022, 7 August 2020 and 29 August 2021:**
  - 12.1. The player inter alia was registered with FERENCVÁROSI TORNA CLUB between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 12.2. FERENCVÁROSI TORNA CLUB is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 13. Registration with club NK Maribor Branik (NZS) between 28 June 2022 and 30 January 2023:**
  - 13.1. The player inter alia was registered with NK Maribor Branik between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 13.2. NK Maribor Branik is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 14. Registration with club KKS LECH Poznań (PZPN) between 30 August 2021 and 18 January 2022:**
  - 14.1. The player inter alia was registered with KKS LECH Poznań between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 14.2. KKS LECH Poznań is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).
- 15. Registration with club GNK Dinamo (HNS) between 6 August 2020 and 6 August 2020, 9 August 2017 and 13 February 2020:**
  - 15.1. The player inter alia was registered with GNK Dinamo between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
  - 15.2. GNK Dinamo is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

**16. Registration with club NK Bravo (NZS) between 20 February 2020 and 2 August 2020:**

- 16.1. The player inter alia was registered with NK Bravo between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 16.2. NK Bravo is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

**17. Registration with club RNK Split (HNS) between 15 July 2015 and 4 July 2017:**

- 17.1. The player inter alia was registered with RNK Split between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 17.2. RNK Split is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).

**18. Registration with club HNK Hajduk (HNS) between 1 January 2012 and 30 June 2015:**

- 18.1. The player inter alia was registered with HNK Hajduk between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
- 18.2. HNK Hajduk is therefore entitled to solidarity contribution for the registration of the player at the club during the aforementioned period(s).



## Conclusion

19. In consideration of the above and in accordance with the FCHR and annexes 4 and 5 to the RSTP, the FIFA general secretariat has determined the entitlement of clubs to training rewards for the above trigger as follows.
20. Real Racing Club de Santander SAD is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
21. Gil Vicente FC is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
22. FERENCVÁROSI TORNA CLUB is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
23. NK Maribor Branik is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
24. KKS LECH Poznań is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
25. GNK Dinamo is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
26. NK Bravo is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
27. RNK Split is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
28. HNK Hajduk is entitled to solidarity contribution for having registered the player at some point in time between the start of the calendar year of the player's 12th birthday and the end of the calendar year of the player's 23rd birthday.
29. No other club is entitled to solidarity contribution.
30. All of the above determinations and decisions are reflected in the EPP in question and/or will be considered in the generation of any Allocation Statement from this EPP for the calculation and distribution of training rewards in accordance with article 13 of the FCHR.

31. More specifically, in case of an international transfer (cf. article 6 FCHR) with payments, this EPP will be considered in the generation of any future Allocation Statement for the calculation and distribution of any solidarity contribution that may become due at a later stage if and when the payments requirements are met.
32. Pursuant to article 57 paragraph 1 of the FIFA Statutes and in accordance with article 10 of the FCHR, this decision may be appealed before the Court of Arbitration for Sport within 21 days of notification. The final EPP will remain available in TMS.
