Dear Sir or Madam,

I am addressing you as the pre-bankruptcy trustee of the company Div grupa d.o.o.

In accordance with Article 54 of Regulation (EU) 2015/848 of the European Parliament and of the Council of 20 May 2015 on insolvency proceedings, we hereby inform you that a pre-bankruptcy proceeding has been opened against DIV GRUPA d.o.o. as the debtor in the Republic of Croatia.

The Decision on opening of pre-bankruptcy proceeding of the Commercial court of Zagreb from 27th of April, 2022, case no. St-1329/2022 (hereinafter: the "Decision"),

has been published on the e-bulletin board of the courts of the Republic of Croatia on the same day at 11:20 a.m., which is when legal ramifications of the opening of the pre-bankruptcy proceeding occurred.

The Decision is considered to have been delivered to all interested parties at the end of the 8th day from the date of publication of the Decision on the e-bulletin board.

We hereby invite you to lodge any claims you may have against DIV GRUPA d.o.o. within 21 days from the date of delivery of the Decision by filing out the official claim form in Croatian, which we submit in attachment to this notice, and submit it to the following address:

Please keep in mind that the claim application must be in Croatian and that all enclosed relevant documentation must be in Croatian and/or translated into Croatian by a certified court interpreter.

**WARNING:** if you do not report your claim then you will lose right to collect the debt from the Div grupa d.o.o.
