1. 31.05.2024 u iznosu od 2.250.000,00 eura
2. 31.01.2025 u iznosu od 2.250.000,00 eura
3. 31.01.2026 u iznosu od 2.250.000,00 eura
4. 31.01.2027 u iznosu od 2.250.000,00 eura

U prilogu ovog maila šaljem prepisku i potvrdu od strane **Financijskog Direktora Benfice - Vasca Silve** o ukupnom iznosu transfera Petra Muse iz Benfice u Dallas i datuma dospjeća rata transfera.

Procedura naplate sredstava od strane NK Zagreba je sljedeća:

- a. Klub (FC Dallas) uplaćuje ratu transfera (ili cijeli transfer, ovisno o dogovoru između klubova) za igrača drugome klubu (FC Benfici)
- b. Klub (FC Dallas) prijavljuje iznos rate koji plaća FC Benfici FIFA Klirinškoj Kući (FIFA Clearing House)
- c. FIFA Klirinška kuća naplaćuje od kluba koji plaća 5% od iznosa rate ili ukupnog iznosa transfera, kao iznos Mehanizma Solidarnosti koje će potom prosljeđivati trening klubovima igrača.
- d. FIFA Klirinška kuća izdaje svoj Allocation statement (Dokument alokacije sredstava trening klubovima), kojim na temelju FIFA putovnice igrača raspodjeljuje sredstva klubovima i u kojemu daje izvještaj o ukupnom iznosu koji se dodjeljuje svakom pojedinom trening klubu.
- e. FIFA Klirinška kuća kontaktira trening klubove tražeći od njih dokumentaciju (Putovnicu službenih osoba, financijske izvještaje, Potvrdu o računu, Izvadak iz registra stvarnih vlasnika)
- f. FIFA Klirinška Kuća odmah nakon predaje i provjere traženih dokumenata prosljeđuje sredstva trening klubovima igrača na temelju izračuna iz Allocation statement (Dokumenta alokacije sredstava trening klubovima)

Cijeli postupak na temelju dosadašnjeg iskustva traje najviše 5 mjeseci, odnosno u roku od 5 mjeseci nakon datuma dospjeća rata direktnih sudionika transfera, sredstva sjedaju na račun trening klubova.

Konkretan slučaj i dosadašnja procedura:

- a. FC Dallas uplatio je prvu ratu transfera FC Benfici 31.05.2024 (vidljivo iz emaila Financijskog Direktora Benfice - Vasca Silve)
- b. FIFA Klirinška kuća izdala je svoj Allocation statement za ratu transfera koja je dospjela 31.svibnja 2024 na dan 18. srpnja 2024, te je pod točkom 12.1. Nogometnom klubu Zagreb odredila za isplatu 60.750,00 eura.
- c. FIFA Klirinška kuća kontaktirala je NK Zagreb 17. rujna radi dostave dokumentacije koju smo ranije opisali kako bi mogla izvršiti uplatu rate na NK Zagreb.

d. Zbog trenutne situacije i zauzetosti kluba situacijom oko postupka st..... nismo još uspjeli dostaviti traženu dokumentaciju, ali normalna procedura bi bila naplata rate u roku od nekoliko dana od kontakta FIFA Klirinške kuće.

Na temelju svega navedenog datumi dospijeća sredstava na račun NK Zagreba i iznosi sredstava od transfera Petra Muse iz FC Benfice u Dallas Fc su sljedeći:

- 31.11.2024 prva rata u iznosu od 60.750,00 eura
- 31.06.2025 druga rata u iznosu od 60.750,00 eura
- 31.06.2026 treća rata u iznosu od 60.750,00 eura
- 31.06.2027 četvrta rata u iznosu od 60.750,00 eura

Naglašavamo da je u prvotnom izračunu napravljena pogreška (izračun je napravljen po starijoj verziji pravilnika o statusu i transferima igrača u kojoj je formula za izračun bila malo drugačija) te da je iznos koji potražujemo 243.000,00 eura umjesto proknjiženih 265.000,00 eura pa smo sukladno tome ispravili knjiženje na način da smo potraživanje za prvu ratu transfera koja je već u dospijeću proknjižili pod:

- 163 Potraživanje za prihode po posebnim propisima (analitički konto u bruto bilanci je 16311 Potraživanje od FIFA Klirinške kuće) – iznos od 60.750,00 eura-dokument za knjiženje je FIFA Allocation statement
- 169 Nedospjela naplata prihoda – nedospjeli ostatak potraživanja od 182.250,00 eura – dokument za knjiženje je FIFA Allocation statement za prvu ratu, FIFA putovnica igrača i e-mail Financijskog Direktora Benfice o iznosu transfera i datumima dospijeća.

Za potrebe potvrđivanja navedenih iznosa i datuma dospijeća sredstava od Mehanizma Solidarnosti od transfera Petra Muse, također šaljemo u prilogu ovog maila:

- Potvrdu o visini transfera, dospijeća i iznosa rata transfera od strane Vasca Silve-Financijskog Direktora Benfice

1. This Allocation Statement with ID SC-9445 corresponds to EPP 37524 for the distribution of training rewards, as established in the EPP determination of the FIFA general secretariat of 7 June 2024.
2. This Allocation Statement determines the amounts of solidarity contribution due from the new club to the training club(s) of the player.

**Calculation of the amount(s) to be distributed (cf. article 10 FCHR)**

3. In case of an international transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12th birthday of the player until the end of the calendar year of the 23rd birthday of the player (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP).
4. The proof of payment of the aforementioned compensation was uploaded in TMS by FC Dallas on 15 July 2024 (cf. article 11 paragraph 1 of the FCHR).
5. The amount declared in the proof of payment is considered to reflect the respective transfer compensation (or instalment thereof), with 5% as solidarity contribution having been withheld by the club making the payment (cf. article 11 paragraph 4 of the FCHR).
6. In the present case, EUR 2,137,500.00 was declared to have been paid to SL Benfica.
7. Thus, the total maximum amount of solidarity contribution generated by the aforementioned compensation amounts to EUR 112,500.00.
8. The payment of solidarity contribution is based on a payment of transfer compensation made in the currency EUR.
9. Solidarity contribution is due according to the number of years (calculated pro rata if less than one year) for which the player was registered with the relevant club(s) between the calendar years of the player's 12<sup>th</sup> and 23<sup>rd</sup> birthdays, as follows (cf. article 1 paragraph 1 of Annexe 5 to the RSTP):

  - e) Calendar year of 16<sup>th</sup> birthday: 10% of 5% of any compensation;
  - f) Calendar year of 17<sup>th</sup> birthday: 10% of 5% of any compensation;
  - g) Calendar year of 18<sup>th</sup> birthday: 10% of 5% of any compensation;

- h) Calendar year of 19<sup>th</sup> birthday: 10% of 5% of any compensation;
- i) Calendar year of 20<sup>th</sup> birthday: 10% of 5% of any compensation;
- j) Calendar year of 21<sup>st</sup> birthday: 10% of 5% of any compensation;
- k) Calendar year of 22<sup>nd</sup> birthday: 10% of 5% of any compensation; and
- l) Calendar year of 23<sup>rd</sup> birthday: 10% of 5% of any compensation.
