

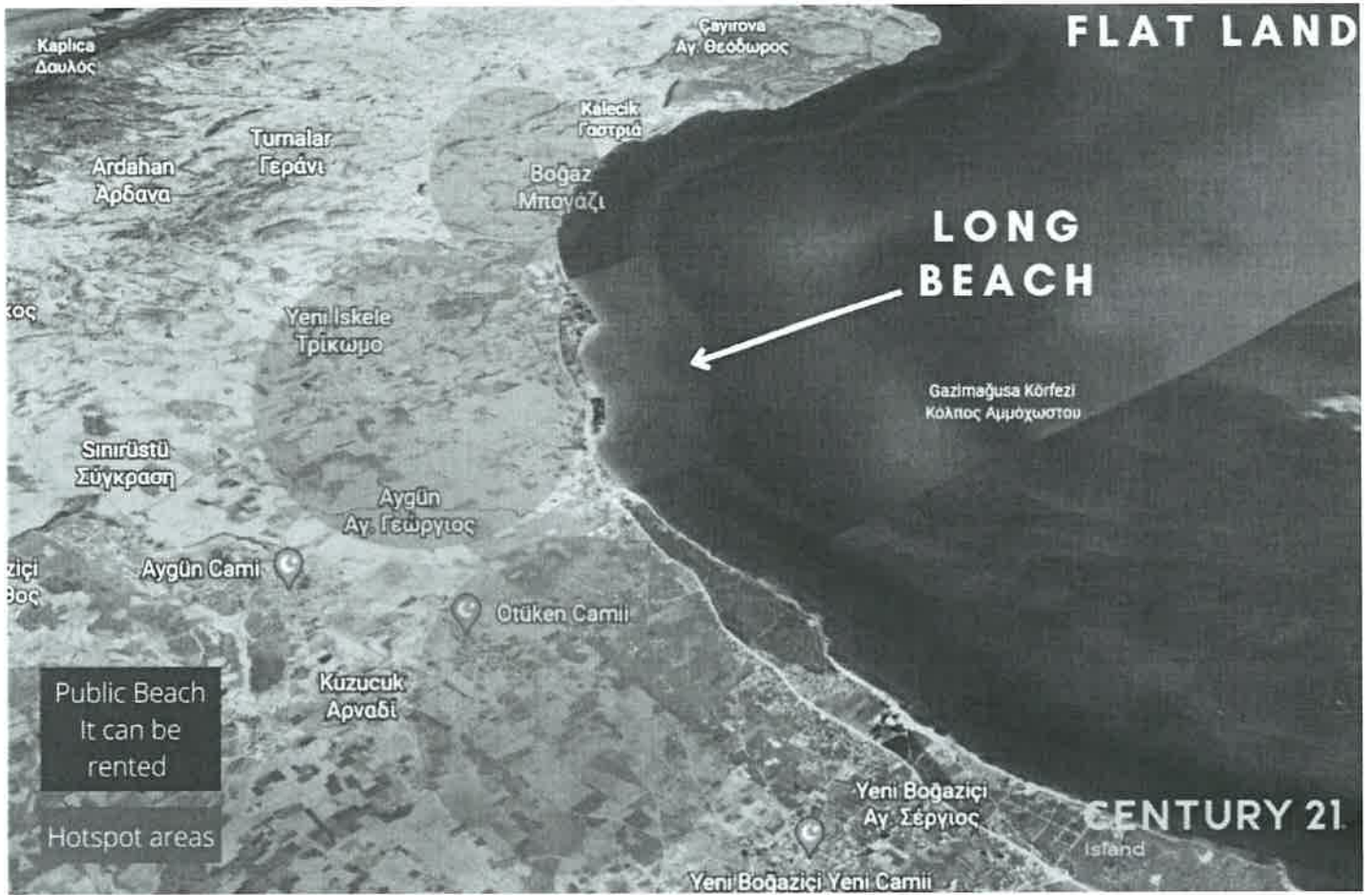

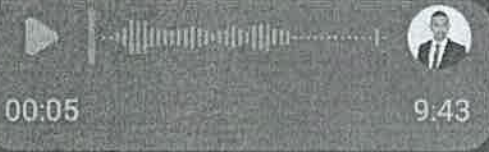

Pozdrav prijatelju CAR Siniša ☺ ,

Evo, jučer smo Anja i ja bila s mojim prijateljima i saznala puno stvari koje su do sada bile nevidljive... ova dvojica mojih prijatelja (oni su muž i žena) poznaju Sinišu već dugo... Suprug ga poznaje od negdje 2014. godine kada su zajedno radili u nekim fondovima, zatim jedno vrijeme nisu radili (putevi su im se razišli), ali prije nekih dvije godine Siniša je nazvao tog mog prijatelja i njegovu ženu i pozvao ih za sudjelovanje u projektu Slaff / Sleo. Oboje (muž i žena) napustili su posao i pridružili se Findesu. Tvrtka Findes bila je i ostala u vlasništvu Emila i njegove supruge. Tamo je zaposlen i Siniša. Danas je Sinišina pozicija u Findesu važnija nego prije nekog vremena. Emil i njegova supruga daju mu slobodne ruke u stvaranju tvrtke, razvoju tvrtke, realizaciji projekata, razvoju Slafa/Sleo-ta i zapravo su osnovali Findes Grupu, gdje je Siniša postavljen za frontmena. U biti, Siniša se svugdje pojavljuje ali se gotovo nigdje ne javlja jer su Emil i njegova žena pravno razotkriveni. Navodno mu Emil i njegova supruga slijepo vjeruju, au ovoj skupini je došlo do poprilične napetosti između zaposlenika i Siniše, a rezultat napetosti su i ostavke na radna mjesta od strane samih zaposlenika. Otišli su vodeći i sposobni ljudi. Ova moja dva prijatelja također su prošle godine (ako me sjećanje ne vara) završili radni odnos i krenuli drugim poslovnim putevima. Kako sam jučer saznao, razlozi za otkazivanja uvijek su bili na Sinišinoj strani jer je previše pričao i obećavao, a premalo ispunjavao. Svi su govorili da je njegov ego problematičan. Zbog potonjeg su zaposlenici osjećali pritisak svojih klijenata, a Siniša kao voditelj i autor projekata nije učinio ništa da se poslovi dovedu do kraja. Nekako mu je ponestalo tlo pod nogama...i on je mnogima ostao dužan...tu dolazi tvoja sumnja odakle mu novac za otplate i ta sumnja je opravdana...nitko tko ima veze s njim ne zna točno kako se uspijeva izvući iz problema, jer tako paušalno radi već najmanje 10 godina i tu praksu nastavlja očito i sada u ovom Slaffovom projektu (dobar je ovaj projekt ali Siniša očito nije vješt i dovoljno iskusan da to sam odgleda do kraja... ovdje vidim da ga možeš samo ti otriježniti, inače sam siguran da ga nitko drugi ne može otriježniti, spustiti na zemlju). Dobio sam informaciju da često zaobilazi neki dogovor kako bi i sam zaradio više. Iz jučerašnjeg razgovora nije otkriveno da bi imao ikakve veze s bilo kakvim ilegalnim skupinama. No doznali smo da je u prošlosti imao problema s grupom Dovec (navodno ih ima i danas), koju i dalje toliko hvali. Sve sam uvjereniji da Siniša neće moći izvesti projekte na Cipru bez tebe i Khaleda. Previše je drzak, arogantan i nespretn da bi to uspio. Ali ima platformu koju koristi sve više korisnika, što znači da ima sve više potencijalnih kupaca nekretnina. To je već puno. Osim toga, kripto valuta SLC konstantno dobiva na vrijednosti u odnosu na euro. Kad smo već kod financijskih izvješća... financijskih izvješća o radu platforme u prošlosti nije bilo... za vjerodostojnost rada platforme, naravno, potrebno je to prezentirati korisnicima platformi i to također javno istaknuti, jer bi na taj način i potencijalni korisnici Slaffa mogli imati dodatni razlog da se priključe ovakvom projektu. Siniša bi ovo trebao redovito objavljivati. Neobjavljivanje ovih izvještaja je, po mom mišljenju, više nego išta drugo zbog njegove aljkavosti (kao što je već rečeno, ima previše ambicija i premalo znanja). Dakle, da zaključimo i iznesemo neke činjenice ali i sumnje koje su jučer isplivale na površinu:

- Siniša je prije mnogo godina sanjao o poslovanju na tržištu nekretnina, ali u Sloveniji nije uspio, niti se previše usudio zbog premoćnih lobija.
- Emila i njegovu suprugu pozna dugo, više od 10 godina
- Emil i supruga mu slijepo vjeruju
- U sklopu Findesa otvorili su i druge tvrtke (Findes+...) i tako osnovali Findes grupu
- Eminencija u svim tim tvrtkama koje su članice Findes grupe je upravo Siniša, a pravno su razotkriveni razni direktori i vlasnici (Emil i njegova supruga).

- Kao voditelj u tim projektima (Slaff i Sleo) poslove vodi potpuno samostalno, velikim dijelom bez znanja, suglasnosti i znanja Emila i njegove supruge
- Emil i njegova supruga i dalje se bave financijskim savjetovanjem i promocijom plemenitih metala, ali bez Slaffa i Slea.
- Mišljenje mojih prijatelja (a i moje mišljenje) je da iz SLC preusmjerava novac i iz drugih projekata fondova, prodavajući kriptovalute SLC pravo u nekretninski projekt i tako drži glavu iznad vode - ali to uskoro više neće biti dovoljno
- Po uzoru na europske banke, Siniša također želi pokupiti novac investitora "iz čarapa" i preusmjeriti ga u nekretnine na Cipru.
- DOVEC mu je prije nekog vremena okrenuo leđa (jedan njegov bivši kolega bavi se, između ostalih, i nekretninama na Cipru, a povezan je s drugom građevinskom grupom koja radi korektno...)
- Baš svi koji su ga napustili govorili su da je njegov ego bio problematičan za točno obavljanje poslova
- Siniša je izvrstan glumac, zna i suze pustiti da postigne milost i ostvarenje vlastitih snova
- Često reagira kao dijete - emotivno, bez iskustva, bez znanja o ispravnoj komunikaciji i korektnim poslovnim odnosima - zna biti i grub u izražavanju, ali samo ako se osjeća jakim

Moj savjet je da ga nekako suočiš sa stvarnošću da bez tebe i Khalede neće moći izvesti projekt nekretnina na Cipru i da je budućnost nekretnina na Cipru tvoja i Khaledova, jer vas dvoje (ti i Khaled) imate pozadinu.
