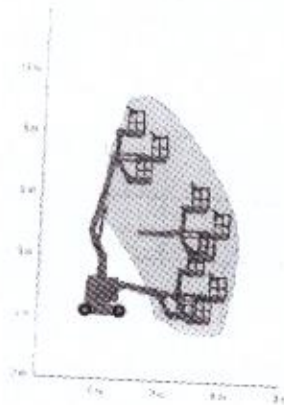

Thankyou for coming to the project In Vienna to meet. Further to our discussions on site we confirm the following

- 1) We agree to keep labour levels for work on SBDU until completion of 12 Operatives. As discussed you agreed to remove the Nightshift rate & will charge the €42 rate per hour per man
- 2) Sean will arrange for MEWPS on 2F SBDU to allow you to continue works.
- 3) We are currently negotiating with Tesla for production to cease temporarily in certain areas to allow us to progress the works. Sean Wilson will advise this but we do appreciate the 3 shift production schedule is causing progress issues.
- 4) As discussed Scott is more than willing to meet you in Madrid. Next week unfortunately is not possible now but it is possible for w/c 13th march. I will not be able to make it as I'm going on holiday that week. If you want me to attend with you I can make it to Madrid early April.

We appreciate your work to date & as discussed we have a good pipeline of work coming through in Germany which this year alone will be Tesla & FRA01 in Frankfurt. Next year we have a further two DC's in Frankfurt & another in Berlin. We would welcome the opportunity to discuss these with you in more detail.
