

LOAN AGREEMENT

THIS AGREEMENT IS MADE AND ENTERED INTO

between

Baltic Ad Hoc SIA, a company incorporated and existing under the laws of Latvia, with its registered office at Mazā Piena iela 11-3, Rīga, LV-1045, Latvia, VAT number: LV40103224329 (the "Lender")

and

FlyMeAway Putnička agencija d.o.o., a company incorporated and existing under the laws of Croatia, with its registered office at Miramarska 24, 10000 Zagreb, Croatia, VAT number: 88917388958 (the "Borrower").

The Lender and the Borrower are hereinafter collectively referred to as the "Parties".

WHEREAS the Lender is willing to grant a loan to the Borrower;

WHEREAS the Borrower desires to obtain from the Lender a loan in the principal amount of forty-three thousand seven hundred thirty-five euro (€ 43.735,00) (the "Loan");

WHEREAS the Parties hereby wish to set forth the terms and conditions agreed between them in that respect;

NOW, THEREFORE, the Parties have agreed as follows:

Article 1 – Loan

- 1.1. Subject to the provisions of this Agreement, the Lender shall pay to the order of the Borrower, on 22.03.2017. (the "Loan Date"), the principal sum of forty-three thousand seven hundred thirty-five euro (€ 43.735,00) (the "Principal Amount").
- 1.2. The Borrower shall use the proceeds of the Loan only for the purpose of its ordinary business.

Article 2 – Interest

- 2.1. Interest shall accrue on the outstanding Principal Amount at the rate of two point sixty-seven per cent (2,67%) per annum, compounded annually.
- 2.2. Interest shall be paid by the Borrower within 8 days following the interest payment date, such date being each anniversary date of this Agreement.
- 2.3. All payments by the Borrower to the Lender hereunder shall be made into a bank account to be specified by the Lender.
- 2.4. All payments hereunder shall be made in euros.

Article 3 – Duration and Repayment plan

- 3.1. The Loan is available to the Borrower for a period of three (3) years (the "Term").



3.2. The Borrower will make repayment to the Lender's bank account as by the following Repayment plan:

- 1st instalment: 01.10.2018. – 6.248,00€
- 2nd instalment: 01.01.2019. – 6.248,00€
- 3rd instalment: 01.04.2019. – 6.248,00€
- 4th instalment: 01.07.2019. – 6.248,00€
- 5th instalment: 01.10.2019. – 6.248,00€
- 6th instalment: 01.01.2020. – 6.248,00€
- 7th instalment: 01.04.2020. – 6.248,00€

3.3. The Borrower is entitled to make earlier repayments without any penalties.

Article 4 – Payments

4.1. All payments due from the Lender to the Borrower under this Agreement will be made by direct deposit to the following bank account:

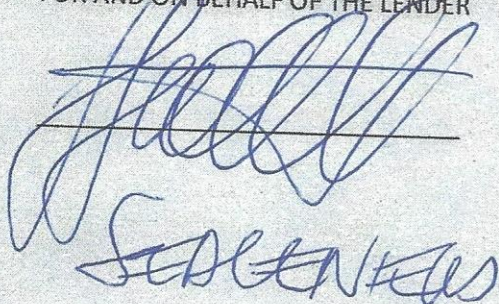
Article 5 – Dispute resolution

5.1. Should any dispute arise about the enforcement or termination of the present Contract, the parties will try to resolve it consensually.

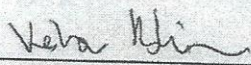
