<p>By this private instrument:</p> <p><u>SUMFINIDADE UNIPESOOAL LDA (Zona Franca da Madeira)</u>, incorporated under the laws of Portugal, with company identification number VAT-ID PT515874620, with its principal place of business at Avenida do Infante 50, 9004-521 Funchal, Portugal, herein represented by its Director NICO TRINKHAUS, German, residing in Estoril, Portugal, bearing of passport Number C4W1HVR8T (Issued by the German Embassy in Lisbon on 10.11.2023, valid until 09.11.2033), appoints TAIANE ALCIDES DE ALMEIDA, Portuguese, Copyright Specialist and Legal Counsel at Sumfinidade Unipessoal LDA, holding Professional ID Card n° 67890E duly registered with the Portuguese Bar Association, with a professional office at Rua Cândido dos Reis, 91, 2780-210 Oeiras, Portugal, granting her the authority and special powers to do all acts that I could do to represent Sumfinidade Unipessoal LDA before the Small Claims Courts of the European Union, under the following terms:</p> <p>PURPOSE This Power of Attorney is made and executed on 11 September 2024 by Nico Trinkhaus, acting as Director of Sumfinidade Unipessoal LDA, herein referred to as the "Principal".</p> <p>GRANT OF AUTHORITY</p> <p>Scope of Authority: The Principal hereby appoints Taiane Alcides de Almeida as its authorized representative (hereinafter referred to as the "Agent") with full power and authority to act in the name, place, and stead of the Principal for the purpose of representing the Principal in European cross-border procedures under the European Small Claims Procedure.</p>	<p>Ovim privatnim aktom:</p> <p><u>SUMFINIDADE UNIPESOOAL LDA (Zona Franca da Madeira)</u>, registrirana prema zakonima Portugala, s brojem identifikacije tvrtke VAT-ID PT515874620, s glavnim poslovnim sjedištem na Avenida do Infante 50, 9004-521 Funchal, Portugal, koju predstavlja njezin direktor NICO TRINKHAUS, Nijemac, s prebivalištem u Estorilu, Portugal, posjednik putovnice broj C4W1HVR8T (Izdana od Njemačke ambasade u Lisabonu 10.11.2023, valjana do 09.11.2033), imenuje TAIANE ALCIDES DE ALMEIDA, Portugalska, specijalistica za autorska prava i pravni savjetnik u Sumfinidade Unipessoal LDA, posjednica profesionalne iskaznice br. 67890E, uredno registrirane kod Portugalske odvjetničke komore, s profesionalnim uredom na adresi Rua Cândido dos Reis, 91, 2780-210 Oeiras, Portugal, dodjeljuje joj ovlasti i posebne moći da obavlja sve radnje koje bih mogao izvršiti kako bih predstavljao Sumfinidade Unipessoal LDA pred Sudovima za male zahtjeve Europske unije, pod sljedećim uvjetima:</p> <p>SVRHA Ova punomoć je sastavljena i potpisana 11. rujna 2024. godine od strane Nico Trinkhausa, koji djeluje kao direktor tvrtke Sumfinidade Unipessoal LDA, ovdje nazivan "Nalogodavac".</p> <p>DODJELA OVLAŠTENJA</p> <p>Opseg Ovlaštenja: Nalogodavac ovim imenuje Taiane Alcides de Almeida kao svog ovlaštenog predstavnika (u daljnjem tekstu "Agent") s punim ovlastima i pravom da djeluje u ime, mjesto i u ime Nalogodavca u svrhu predstavljanja Nalogodavca u europskim prekograničnim postupcima prema Europski postupak za sporove male vrijednosti.</p>

<p>Specific Powers:</p> <p>The Agent is authorized to:</p> <ul style="list-style-type: none"> - Represent the Principal in judicial and administrative proceedings before the Small Claims Courts of the European Union. - Take all necessary measures for the defense of the interests of Sumfinidade Unipessoal LDA, including the presentation of documents, response of court requests, manifestation against claims made by the opposing side, conducting hearings, and accepting commitments. - Submit requests, issue opinions, and meet court requirements. - Initiate, participate in, submit to alternative dispute resolution, settle, oppose, propose, or accept a compromise with respect to a claim existing in favor of or against Sumfinidade Unipessoal LDA, or intervene in litigation relating to the claim. - For all litigation process relevant actions, including legal actions initiated by a counterclaim, retrial, and enforcement of payment. - Appeal against a court order, waive appeal, and withdraw appeal, including commencement and withdrawal of counterclaims. - Order a local counsel as well as an agent for higher instances. - Settle disputes with a settlement deal and release the object of dispute. - Acknowledge the claims made by the opposing side and present a response to them. - Respond to or submit requests related to claims that are already in progress. 	<p>Specifične Ovlasti:</p> <p>Agent je ovlašten da:</p> <ul style="list-style-type: none"> - Predstavlja Nalogodavca u pravnim i administrativnim postupcima pred Sudovima za male zahtjeve Europske unije. - Poduzima sve potrebne mjere za zaštitu interesa Sumfinidade Unipessoal LDA, uključujući predstavljanje dokumenata, odgovaranje na zahtjeve suda, očitovanje protiv zahtjeva suprotne strane, vođenje rasprava i prihvaćanje obveza. - Podnosi zahtjeve, izrađuje mišljenja i ispunjava sudske zahtjeve. - Pokreće, sudjeluje u, predaje na alternativno rješavanje sporova, nagoditi, proturječi, predlaže ili prihvaća nagodbu u vezi s zahtjevom u korist ili protiv Sumfinidade Unipessoal LDA, ili intervenira u postupcima u vezi s tim zahtjevom. - Obavlja sve radnje relevantne za postupak parnice, uključujući pravne radnje pokrenute protutužbom, ponovnim suđenjem i prisilom za plaćanje. - Žali se na sudsku odluku, odustaje od žalbe i povlači žalbu, uključujući pokretanje i povlačenje protutužbi. - Nalogodavcu dodijeli lokalnog pravnog savjetnika kao i zastupnika za više instance. - Rješava sporove postizanjem nagodbe i oslobađa predmet spora. - Prizna zahtjeve suprotne strane i predstavi odgovor na njih. - Odgovara na ili podnosi zahtjeve u vezi sa zahtjevima koji su već u tijeku.

<p>- To perform all acts necessary for the fulfilment of the purpose of this power of attorney.</p> <p>Validity: This Power of Attorney is valid for all instances, possible side- and follow-up procedures, such as legal enforcements, appeals, revision requests, arrests, injunctions, assessments of costs, foreclosure auctions, bankruptcy, and bailment procedures.</p> <p>Jurisdiction: This Power of Attorney is specifically limited to matters related to the European Small Claims Procedure in Croatia and Portugal.</p> <p>Duration: This power of attorney is valid in Croatia and Portugal and for all matters covered by the European Small Claims Procedure, as defined by Regulation (EU) No. 861/2007, from 11 September 2024.
