### **EPP and training rewards (cf. article 9 FCHR)**

1. This Allocation Statement with ID SC-5141 corresponds to EPP 15752 for the distribution of training rewards, as established in the EPP determination of the FIFA general secretariat of 29 March 2023.
2. This Allocation Statement determines the amounts of solidarity contribution due from the new club to the training club(s) of the player.

### **Calculation of the amount(s) to be distributed (cf. article 10 FCHR)**

3. In case of an international transfer of a professional player (either on a permanent or on a loan basis) during the course of a contract, 5% of any compensation paid within the scope of this transfer, not including training compensation paid to the player's former club, shall be deducted from the total amount of this compensation and distributed by the new club as a solidarity contribution to the club(s) involved in the player's training and education over the years as from the start of the calendar year of the 12th birthday of the player until the end of the calendar year of the 23rd birthday of the player (cf. article 1 paragraph 1 and article 1 paragraph 2 of Annexe 5 to the RSTP).
4. The proof of payment of the aforementioned compensation was uploaded in TMS by Southampton on 13 February 2024 (cf. article 11 paragraph 1 of the FCHR).
5. The amount declared in the proof of payment is considered to reflect the respective transfer compensation (or instalment thereof), with 5% as solidarity contribution having been withheld by the club making the payment (cf. article 11 paragraph 4 of the FCHR).
6. In the present case, EUR 1,662,500.00 was declared to have been paid to GNK Dinamo.
7. Thus, the total maximum amount of solidarity contribution generated by the aforementioned compensation amounts to EUR 87,500.00.
8. The payment of solidarity contribution is based on a payment of transfer compensation made in the currency EUR.
9. Solidarity contribution is due according to the number of years (calculated pro rata if less than one year) for which the player was registered with the relevant club(s) between the calendar years of the player's 12<sup>th</sup> and 23<sup>rd</sup> birthdays, as follows (cf. article 1 paragraph 1 of Annexe 5 to the RSTP):
  - a) Calendar year of 12<sup>th</sup> birthday: 5% of 5% of any compensation;
  - b) Calendar year of 13<sup>th</sup> birthday: 5% of 5% of any compensation;
  - c) Calendar year of 14<sup>th</sup> birthday: 5% of 5% of any compensation;
  - d) Calendar year of 15<sup>th</sup> birthday: 5% of 5% of any compensation;
  - e) Calendar year of 16<sup>th</sup> birthday: 10% of 5% of any compensation;
  - f) Calendar year of 17<sup>th</sup> birthday: 10% of 5% of any compensation;
  - g) Calendar year of 18<sup>th</sup> birthday: 10% of 5% of any compensation;

- h) Calendar year of 19<sup>th</sup> birthday: 10% of 5% of any compensation;
- i) Calendar year of 20<sup>th</sup> birthday: 10% of 5% of any compensation;
- j) Calendar year of 21<sup>st</sup> birthday: 10% of 5% of any compensation;
- k) Calendar year of 22<sup>nd</sup> birthday: 10% of 5% of any compensation; and
- l) Calendar year of 23<sup>rd</sup> birthday: 10% of 5% of any compensation.

## Conclusion

11. The new club Southampton (The FA) shall pay solidarity contribution to the training club(s) of the player in the total amount of EUR 84,890.96.
12. The following training club(s) shall receive the following payment(s).
  - 12.1. The training club NK Trešnjevka (HNS) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 11,003.42.
  - 12.2. The training club NK Kustošija (HNS) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 10,536.74.
  - 12.3. The training club HNK Rijeka (HNS) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 1,654.11.
  - 12.4. The member association Croatian Football Federation on the basis of the registration of the player with the disaffiliated training club NK Inter-Zaprešić (HNS) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 44,028.89.
  - 12.5. The training club SPEZIA CALCIO S.R.L. (FIGC) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 6,640.41.
  - 12.6. The training club JEONNAM DRAGONS Football Club (KFA) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 7,311.64.
  - 12.7. The training club NK Celje (NZS) shall receive solidarity contribution payments from the new club of the player in the amount of EUR 3,715.75.
13. The payments defined in this Allocation Statement shall be made through the FIFA Clearing House entity (FCH), in accordance with articles 12, 13 and 14 of the FCHR. The FCH will contact the new club, the relevant training clubs and the relevant member associations to process these payments.
14. According to the relevant provisions of RSTP and FCHR, it is the new club that will be required to pay training rewards due to the training clubs concerned, and the new club may not assign responsibility to pay the amount requested to any other party.

15. Pursuant to article 57 paragraph 1 of the FIFA Statutes and in accordance with article 10 of the FCHR, this decision may be appealed before the Court of Arbitration for Sport within 21 days of notification. The final EPP will remain available in TMS.
