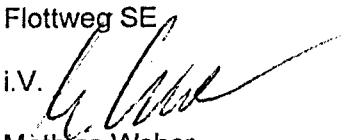

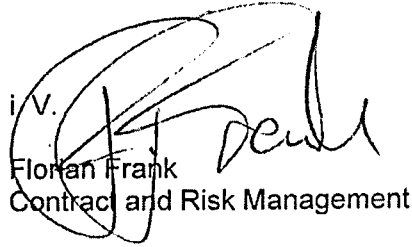

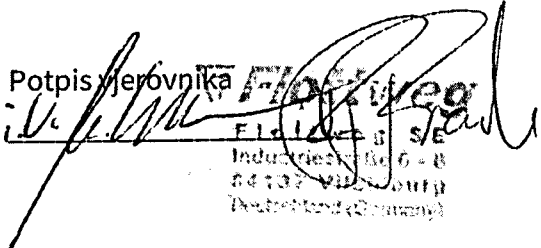

GENERAL TERMS AND CONDITIONS

General Conditions of Delivery and Payment

Version: 01.02.2021

These General Conditions of Delivery and Payment shall apply for:

1. persons who act in execution of their commercial or freelance professional activity at the time a contractual agreement is concluded (entrepreneurs);
2. legal entities under public law or a public-law special asset.

I. General Provisions

1. All deliveries and services shall be governed by these conditions as well as any separate contractual agreements. Any deviating purchasing conditions of the customer shall not form part of the contractual conditions even by acceptance of an order.
2. A contract shall be concluded – unless otherwise agreed – with Flottweg's order confirmation.
3. Without contractual limitation and according to legal provisions, the customer may offset claims resulting from this Agreement and aimed at payment due to failure of Flottweg to deliver or due to defects on the machine/equipment against Flottweg's claim for payment of the contract price. The customer may only offset claims other than those listed in sentence 1 of this paragraph against claims from Flottweg if these are undisputed or legally enforceable or ready for decision. The customer shall only be entitled to withhold payments if its counterclaims are undisputed or legally enforceable or ready for decision. In all other respects, reference is made to the contractual provisions regarding the terms of payment.

II. Subject of Contract

1. Flottweg shall be obliged to deliver to the customer, i.e. transfer of the ownership and the procurement of ownership of the machine/equipment described in the technical specifications.
2. The scope of Flottweg's services shall be decided by the specifications applying at conclusion of the Agreement. The specifications of the machine/equipment shall be not constituted as a guarantee for their condition nor any assurance as to their characteristics. The provision of guarantees as to the condition of the machine/equipment and assurances as to its characteristics by Flottweg shall be made in writing.

III. Delivery Time, Delay

1. The Delivery Time shall be in accordance with the agreements between both parties.
2. The adherence to the delivery date by Flottweg shall require the clarification between the contractual parties of all commercial and technical issues and the customer's fulfilment of all its obligations such as e. g. procuring all the necessary official certificates or permits or making a down payment, as well as the fulfilment of any other obligation if any agreed on (e.g. issuing any payment bond or Letter of Credit). The delivery date shall be extended accordingly if this is not the case. Any expenses arising out of a delay of the before mentioned obligations of the customer, shall be charged to the customer beginning one month after the appropriate due dates of such obligations. This shall not be the case if Flottweg is responsible for the delay.
3. Adherence to the delivery date shall be subject to correct and punctual self-delivery. Flottweg shall announce foreseeable delays as soon as possible.
4. The delivery date shall be deemed to have been fulfilled if the machine/equipment has left the Flottweg factory or has been announced as ready for dispatch within the agreed timeline. As far as an acceptance is to take place pursuant to article 640 of the Civil Code, other than in the case of justified refusal or unless agreed otherwise, the acceptance date or otherwise the goods being ready for acceptance shall be definitive.
5. If the shipping or acceptance of the machine/equipment pursuant to article 640 of the Civil Code is delayed due to the customer, the customer shall be charged for the costs due to the delay commencing one month after notification that the goods are ready for shipping or acceptance.
6. If non-compliance with the delivery time is due to Force Majeure in the meaning of unforeseeable circumstances which are beyond Flottweg's control, the delivery time shall be extended accordingly. Force majeure circumstances shall include, but are not limited to, acts of war, epidemics, pandemics, natural disasters, strikes, labour disputes and

and any governmental restrictions. Flottweg shall inform the customer as soon as possible as to the start and the end of such circumstances. Insofar as Flottweg is required to perform services, these may be refused due to Force Majeure. If travel into or of a country is only possible with impediments or under special circumstances, the customer shall bear any costs incurred in this context.

7. If it finally becomes impossible for Flottweg to carry out all the services before the risk is transferred, the customer has the right to withdraw from the Agreement without stating any deadline. The customer may also annul the Agreement in case a part of the delivery becomes impossible and if he is of a justified interest in a refusal of a partial delivery. In any other case the customer shall pay the contractual price according to the partial delivery. The same shall apply for any case of inability of Flottweg. If an impossible or inability takes place during the delay in acceptance or if the customer is solely or largely responsible for these circumstances, the customer shall remain obliged to provide consideration.
8. If the customer is entitled to withdraw from the Agreement due to delay of Flottweg in providing a service, the customer shall be obliged to declare within a reasonable period of time whether it intends to exercise its right of withdrawal. In the event of a delay on the part of Flottweg in providing a service, the customer shall set a reasonable period of grace and send Flottweg a written reminder to this end.
The customer's right of withdrawal based on the above-mentioned delay shall only arise upon expiry of the aforementioned grace period or, in the case of contractually agreed liquidated damages, upon reaching the relevant limit of liability.

IV. Payment, Taxes

1. The contract price for the deliveries and Flottweg's other services shall be stated in the price list, including packaging. Any potential value added tax shall be not included in the price. If VAT is applicable, the customer shall pay the agreed contract price and additionally the applicable VAT, after the relevant invoice was issued. The VAT rate applicable at the time the service is provided shall be decisive for the calculation of the VAT. All amounts are generally payable without any deduction or holdback of taxes or other fees. If the customer is obligated to deduct or holdback taxes or fees from the contract price, the customer has to pay the additional sums, which are necessary that Flottweg receives the amount Flottweg would receive without any deduction or holdback.

V. Packaging, Transfer of Risk

1. The machine/equipment shall be shipped in packaging that warrants the integrity of the machine/equipment against damage and corrosion when transported under normal and foreseeable circumstances. Unless the Agreement provides otherwise, the marking shall be made in waterproof colours on three sides in German and state the following: Agreement No., package No., up, do not tilt, gross weight, net weight and recipient's address.
2. Unless stated otherwise in the Agreement, the risk shall pass to the customer after the machine/equipment has left the factory even if partial deliveries take place or if Flottweg has accepted other services, e. g. shipping costs or delivery and assembly.
3. If shipping is delayed or does not take place due to circumstances not due to Flottweg, the risk shall pass to the customer on the day on which the goods are announced as ready for shipping.
4. Partial deliveries shall be allowed as far as they are reasonable for the customer and insofar as not otherwise contractually agreed.

VI. Documentation

The scope of supply comprises of:

- Planning documents (in German or English). The planning documents will be provided in the form of Acrobat Reader files (PDF). Paper copies can be provided on request. Dimensional drawings are available in 2D Autocad.
- Operating instructions and maintenance manuals, in the language of the EU member state where installed, and in English for deliveries outside the EU. The instructions and manuals will be provided in the form of Acrobat Reader files (PDF). Paper copies can be provided on request.

Reports are monolingual and completed to the Flottweg standard. The documentation for machine accessories, purchased parts and system components etc. is to the appropriate standards of the manufacturer and in the standard language of the manufacturer. Special requests such as multi-lingual reports, documentation to the standard of the client, and additional copies may be sent on account.

VII. Other Duties and Obligations of the Customer

1. The proper and timely performance of the delivery and services by Flottweg shall require the proper and timely carrying out of all necessary cooperation by the customer.
2. Any defects in Flottweg's deliveries and services shall be claimed by the customer in writing in a comprehensible and detailed form, stating all information useful for the detection of the defect; in particular, the stages of work which led to the appearance of the defect, the consequences as well as the visual appearance of the defect shall be stated.
3. Subject to an alternative contractual agreement, the customer shall also be obligated in particular:
 - a) to refrain from repairing the machine/equipment itself or from having third parties do so improperly;
 - b) to refrain from carrying out alterations to the machine/equipment without authorization and in particular without Flottweg's prior approval;
 - c) to refrain from using the machine/equipment in an unsuitable or improper manner;
 - d) to refrain from carrying out defective erection or commissioning;
 - e) to refrain from handling the machine/equipment in an improper or negligent manner;
 - f) to maintain the machine/equipment properly;
 - g) to refrain from using unsuitable materials;
 - h) to select a suitable ground for the machine/equipment;
 - i) to refrain from exposing the machine/equipment to chemical, electrochemical or electrical influences.

VIII. Transfer of Ownership

1. Flottweg shall reserve ownership of the machine/equipment until receipt of all payments including any additional ancillary services under the delivery agreement.
2. During the period of reservation of ownership, Flottweg shall be entitled to insure the machine/equipment at the customer's expense against theft, breakage, fire or water damage or other damage unless it is clear that the customer has itself concluded such insurance.
3. The customer may not sell, pledge or transfer the machine/equipment by way of security during the period of reservation of ownership. The customer shall inform Flottweg immediately in the event of distraint, seizure or other order from third parties during the period of reservation of ownership.
4. During the period of reservation of ownership in case the customer acting in a manner inconsistent with the Agreement, particularly in the case of late payment, Flottweg shall be entitled to take back the machine/equipment following a demand for payment and the customer shall be obliged to hand it over.
5. Based on the reservation of ownership, Flottweg may only demand the return of the machine/equipment if it has cancelled the Agreement.
6. During the period of reservation of ownership Flottweg shall be entitled to withdraw from the Agreement and to demand the immediate return of the machine/equipment in case of opening insolvency proceedings of the customer's assets.

IX. Customer's Rights in the Event of Mal-Performance

For any Material Defects and Defects of Title Flottweg shall warrant as follows:

1. Material Defects
 - a) All those parts which turn out to be useless or considerably impaired with regard to their usability shall be repaired or supplied anew, free of charge at Flottweg's discretion, due to circumstances which occurred prior to passing of risk. Flottweg shall immediately be informed in writing if such defects are found. The replaced parts shall be Flottweg's property.
 - b) The customer shall, on consultation, give Flottweg the necessary time in order to carry out all improvements and replacement deliveries that appear necessary.
 - c) Flottweg shall bear the costs of the replacement part and the shipping as far as the complaint turns out to be justified that arising from the improvement or replacement delivery. Flottweg shall also bear the costs of removal and installation and the costs of providing the necessary assembly and support staff including travelling expenses provided this does not lead to disproportionately high costs for Flottweg.
 - d) The customer shall, in line with legal provisions be entitled to withdraw from the Agreement if Flottweg – bearing in mind the legal exceptions – allows an appropriate deadline given to Flottweg for improvement or replacement delivery due to a material defect to pass without result. The customer shall be entitled to a reduction of the contractual price in the event of an insignificant defect. There shall otherwise be no right of reduction of the contractual price.
 - e) Any further claims shall be according to Section X. of these General Conditions of Delivery and Payment.

- f) The aforementioned warranty obligations pursuant to Section IX. No. 1 a) – e) shall not apply to defects or damages which have been caused for the following reasons:
- Improper or incorrect use by the customer or third parties
 - Faulty assembly or commissioning by the customer or third parties
 - Use of spare parts not purchased via Flottweg
 - Improper maintenance
 - Repair by the customer or third parties
 - Use of unsuitable materials
 - Use of the machine/equipment in relation to mediums, substances or mixtures that deviate from the contractually agreed scope of use
 - Corrosion, erosion, normal wear and tear or in relation to any parts which are naturally subject to heavy wear or which have a reduced lifetime due to their nature

2. Defects of Title

- a) If the use of the machine/equipment leads to the violation of property rights in the country of use, Flottweg shall, in principle and at its own expense, grant the customer the right to further use or modify the machine/equipment in a manner acceptable to the customer so as to rectify the violation of property rights. If this is not possible subject to economically appropriate conditions or within an appropriate time frame, the customer shall be entitled to withdraw from the Agreement. Under these conditions, Flottweg shall also be entitled to withdraw from the Agreement. The customer shall be entitled to a reduction of the contractual price in the event of an insignificant defect. There shall otherwise be no right of reduction of the contractual price.
- b) The obligations of Flottweg specified in Section IX. no. 2 a) of these conditions shall apply subject to Section X. in a case of infringement of property right or copyright. They only shall apply if:
- i. the customer informs Flottweg without delay of any alleged violations of property rights,
 - ii. the customer supports Flottweg to an appropriate extent in defending against the asserted claims or enables Flottweg to carry out the above-mentioned modification measures,
 - iii. Flottweg reserves all defensive measures, including extra-judicial regulations,
 - iv. the defect of title is not based on an instruction from the customer and
 - v. the legal violation was not caused by the customer altering the machine/equipment on its own initiative or using it in a manner contrary to the Agreement.

X. **Liability**

1. Flottweg shall be liable under legal provisions without any contractual limitation
 - a) for damage due to violation of a guarantee provided by Flottweg or a characteristic ensured by Flottweg,
 - b) due to wilful intent,
 - c) for damage due to Flottweg fraudulently concealing a defect,
 - d) for damage due to injury to life, limb and health due to an intentional or negligent breach of duty by Flottweg or other intentional or negligent conduct of one of Flottweg's legal representatives or vicarious agents,
 - e) for damage other than that listed under the provision in the previous sentence, due to an intentional or grossly negligent breach of duty by Flottweg or other intentional or grossly negligent conduct of one of Flottweg's legal representatives or vicarious agents,
 - f) under the Product Liability Act
2. In cases other than that provided for under paragraph 1, Flottweg's liability shall be limited to compensating contractually typical and foreseeable damage provided that such damage is due to negligent violation of significant obligations by Flottweg or one of Flottweg's legal representatives or vicarious agents. Significant obligations shall be those obligations, the fulfilment of which enables the proper carrying out of the Agreement in the first place and the adherence to which the customer may regularly count and trust.
3. Flottweg's liability due to negligence shall be excluded in all other cases than those stated in paragraphs 1 and 2.
4. This shall not affect the plea of contributory negligence.
5. The aforementioned provisions shall apply to all contractual and non-contractual claims for compensation from the customer irrespective of the legal basis of it and in accordance with Flottweg's liability for the reimbursement of wasted expenses.

XI. Limitation

1. Any claims of the customer shall expire in accordance to legal provisions and without any contractual limitations:
 - a) in the case of liability due to intent,
 - b) in the case of defects on the machine/equipment as far as Flottweg has fraudulently concealed the defect or as far as Flottweg has provided a guarantee for the machine/equipment,
 - c) in the case of defects on the machine/equipment if the defect is based on a third party's rights in rem based on which the surrender of the machine/equipment may be demanded or any other right provided for in the Land Register,
 - d) in case of defects on a structure or a machine/equipment that has been used in accordance with its normal application as a structure and has led to its defectiveness,
 - e) in case of supplier regress on final delivery to a consumer (article 478 of the Civil Code),
 - f) in case of compensation of damage
 - i. due to an intentional or grossly negligent dereliction of duty by Flottweg or other intentional or grossly negligent conduct of one of Flottweg's legal representatives or vicarious agents,
 - ii. due to injury to life, limb and health due to an intentional or negligent dereliction of duty by Flottweg or other intentional or negligent conduct of one of Flottweg's legal representatives or vicarious agents,
 - iii. under the Product Liability Act.
2. In cases other than those provided for in paragraph 1, the limitation period for customer's claims due to material defects of the machine/equipment shall be one year from delivery date of the machine/equipment.

XII. Export, End-Use Certificate, Prohibition for the use of weapons

1. Restrictions may apply to the delivery of goods and services as well as actions in advance, especially acc. to applicable export control provisions. The customer shall be obliged to promptly provide Flottweg with any information required by Flottweg to perform a verification of the end-use incl. the final use.

Fulfilment of an agreement by Flottweg shall be subject to the provision that this is not prevented by any obstacle due to applicable national or international provisions under foreign trade or customs legislation or embargoes (or other sanctions). Moreover, the necessary verifications to be performed by Flottweg or the time of processing by competent authorities of approvals applied for may, in some circumstances, also cause delays, overriding agreed deadlines and delivery times and extending them by their duration. Where approvals required for export or import, etc. are not granted or if the agreement must not be fulfilled on the delivery date (= agreed delivery time incl. delay by necessary verification at Flottweg or handling by the competent authorities) due to an applicable aforementioned provision, the agreement shall be deemed not concluded regarding the relevant part. The customer shall not be entitled to assert claims for damages if fulfilment is not effected at all or only late for one of the aforementioned obstacles.
2. The customer shall confirm that goods and deliveries of Flottweg will be used for civil non-critical end-uses only. The critical end-uses may include: uses in connection with ABC weapons and missiles, use in nuclear facilities for civil purposes, military end-uses, uses in the Crimea region or Sevastopol, uses for crude oil exploration in Russia, etc. Upon request, the customer shall issue an end-use certificate for Flottweg, stating the end-use, in good time in advance.
3. Where the customer intends to re-deliver goods or services received from Flottweg, the customer must inform Flottweg of the specific project promptly before the transaction is initiated and await Flottweg's written acceptance. Where the customer re-delivers / passes on the goods received from Flottweg (= hardware, software, technology and related documentation, notwithstanding the type of provisioning), the customer shall be obliged to observe the applicable export control provisions. The customer shall confirm, inter alia, that the customer will refrain from any transaction involving individuals, organisations or bodies, etc. named on an applicable sanctions list or, in whole or in part, indirectly or directly, are dominated or controlled, etc. by one or several listed/sanctioned individual(s).
4. In case of any violation of legal and contractual obligations, Flottweg reserves the right to terminate the agreement extraordinarily and to take further legal steps. In addition, the customer undertakes, in case of any violation caused by the customer, to indemnify Flottweg from all claims asserted by third parties vis-à-vis Flottweg and to compensate Flottweg for any damage and expense incurred by Flottweg in this context.
5. The customer is solely responsible for the handling of the import declaration in his own country unless otherwise agreed. For this purpose, the customer shall request all necessary documents and information from FW and check them for completeness and correctness. In the event of mistakes in the import declaration, the customer shall be liable exclusively. The customer shall indemnify Flottweg against any claims by third parties and shall be solely liable for such claims. Any recourse to FW shall be excluded, even if FW has passed on information, that was inadequate.

XIII. Product and Safety Provisions, Health and Safety Provisions

1. Flottweg shall be responsible to be in compliance with the applicable German product and safety provisions and the technical norms. The observing and carrying out of the product and safety provisions of the country in which the machine/equipment is to be commissioned and operated shall be customer's responsibility. At conclusion of an Agreement the customer shall inform Flottweg in writing about any special issues arising from these provisions.
2. Within a reasonable period before the arrival of Flottweg's personnel the customer shall be obliged to inform Flottweg in writing about any risks of health and safety for Flottweg's personnel that may exist when carrying out the services for commissioned and/or installation and if necessary, which kind of measures shall be required for observing legal health and safety provisions and any accident prevention regulations. The customer undertakes to submit a risk analysis form provided by Flottweg in good time before the arrival of the personnel. The Customer shall be responsible for occupational safety and health, in particular for compliance with all accident prevention and safety regulations for which it is responsible as an employer and customer.

XIV. Intellectual property rights concerning the scope of delivery and the use of software

1. In case the scope of supply includes software, Flottweg shall grant the customer a non-exclusive right to use the software including its documentation. This shall be provided only for use on the respective machine/equipment. The software shall not be used on more than one system. The customer shall only reproduce, revise, compile the software or convert it from the object code to the source code (article 69a, et seq UrhG) if legally permitted. The customer shall be obliged not to remove or alter any manufacturer's details, like copyright marks, without Flottweg's prior approval. Title of all other rights to software and documentation, including copies thereof, shall remain with Flottweg or the software supplier. The issuance of sublicenses shall be prohibited. The handover of the source code by Flottweg is excluded unless otherwise agreed.
2. Flottweg shall reserve copyrights and property rights relating to samples, estimates, drawings, etc., information of a physical and non-physical nature, also in electronic form; these may not be made available to third parties. Flottweg shall be obliged not to disclose any confidential information to third parties without approval from the customer.
3. Flottweg warrants that the scope of supply and services does not infringe any third party property rights. Third party property rights include all industrial property rights, in particular patent rights, utility model or design rights, copyrights or ancillary copyrights or trademark rights. In the event of an identified infringement of industrial property rights, Flottweg shall compensate the claims of third parties. In addition, Flottweg shall modify the scope of supply and performance at its own expense in a reasonable manner so that the right to further use of the machine/equipment is ensured with the exclusion of further infringement of industrial property rights by the customer. If it is not possible to carry out modification actions on economically reasonable terms or within a reasonable period, the customer shall be entitled to withdraw from the contract in accordance with the statutory provisions.
4. In addition, developments, inventions, innovations, results or other information provided within the scope of the supply of goods and services, which may be registered as industrial property rights (e.g. patents, utility models or registered designs) shall, as far as legally possible, become the property of Flottweg. Flottweg shall be the sole applicant for the aforementioned industrial property rights, unless Flottweg waives its right in writing. It is hereby pointed out that property rights already applied for by the parties at the time of the conclusion of the contract or information or know-how relevant to property rights already existing at that time in any other form of the parties, shall remain in the relevant ownership. The rights from §12 PatG remain unaffected by this and apply in addition.

XV. Transfer of rights and obligations; Assignment

The contractual rights and obligations of the parties are not transferable. If the assignment of a monetary demand has been concluded via agreement with the debtor and if the legal transaction on which this demand is based constitutes a trading transaction for both parties or if the debtor is a legal person under public law or a special fund under public law, the assignment shall nevertheless take effect. In particular Flottweg shall be entitled to assign its claims for payment of the contract price to third parties.

XVI. Final Provisions

1. The Agreement between Flottweg and the customer shall be subject to the law of the Federal Republic of Germany. If services are part of the scope of supply and services, § 650 BGB shall apply.
2. Place of jurisdiction shall be the court in the district of Flottweg's registered office. However, Flottweg shall also be entitled to institute proceedings at the court in the district of the customer's registered office.

3. Amendments and additions to this Agreement shall be made in writing for legal reasons. This shall also apply to the rescission of this clause. Each party may demand the written form of any amendment or addition to this Agreement. Individual agreements are reserved. There are no ancillary agreements.
4. Notifications and declarations to be made by the customer to Flottweg or a third party shall be made in writing to take effect.
5. The Agreement shall also be binding if single contractual provisions are ineffective or infeasible.
