So:

On 17.04.2018, a loan was made for opening an account in the amount of 100.00 euros, or 741.27 kn for opening an account

On 19.04.2018, a loan of 100,000.00 euros and 740,757.90 kn was paid

On 30.04.2018, part of the loan in the amount of EUR 50,000.00 and HRK 370,656.50 was repaid

On 19.11.2018, the second part of the loan was returned.

Interest on a given loan at the discount rate of the Croatian National Bank was calculated and amounted to HRK 10,400.81, which amounts to **EUR 1,375.50** at the middle exchange rate of the Croatian National Bank on the day of the opening of bankruptcy on November 20, 2020 as the day on which the amounts of all claims and liabilities are determined.

Account No. LT103510000092086352 belonging to Elite Trading Business d.o.o. was opened on 2018-03-22 and closed on 2019-11-29. Upon closing the account, the outstanding balance was transferred to the closed account funds account and was never claimed. Please see attached a confirmation of transfer for the remaining funds. We can transfer the unclaimed balance of 0.70 EUR to the account No. HR62 2340 0091 1900 2857 8. Please indicate in the reply to this e-mail if you would like us to do so.

Secure Nordic Payments UAB (until 2019-12-19 known as Mistertango UAB) does not and has not provided interest-bearing accounts. The account held No. LT103510000092086352 held by Elite Trading Business d.o.o. was a current account, to which funds may be deposited and transferred out, and for which Elite Trading Business d.o.o. paid fees to Mistertango UAB. Additionally, I am not aware of any loan agreement between Secure Nordic Payments UAB or Mistertango UAB and Elite Trading Business d.o.o. Finally, as you can see in the attached full account statement, all of the funds except for the 0.70 EUR, have been transferred outside of the client's account. Therefore, we do not see any reason why would Secure Nordic Payments UAB pay any interest fees to the bankruptcy commissioner of Elite Trading Business d.o.o. Please provide additional clarifications if we misunderstand anything.
