Special Power of Attorney

hereby appoint and authorise the following

- da u prostorijama Financijske Agencije ili bilo kojim drugim putem, zatraži te obavi uvid u Očevidnik neizvršenih osnova za plaćanje za Društvo, da ishodi i pribavi informacije u bilo kojem primjenjivom obliku iz Očevidnika neizvršenih osnova za plaćanje za Društvo i da poduzme sve druge radnje u vezi s predmetom ove punomoći, a koje su potrebne kako bi se pribavili podaci iz Očevidnika neizvršenih osnova

each of them acting individually and independently, to undertake in my name and on my behalf the following legal actions:

- to request and conduct an inspection of the Register of Unexecuted Bases for Payment (Očevidnik neizvršenih osnova za plaćanje) concerning the Company at the premises of the Financial Agency (FINA) or through any other available means, to obtain and collect information from the Register of Unexecuted Bases for Payment concerning the Company in any applicable form, and to undertake all



za plaćanje koji su potrebni za pokretanje stečajnog postupka nad Društvom;

other actions related to the subject matter of this power of attorney which may be necessary in order to obtain data from the Register of Unexecuted Bases for Payment required for the initiation of bankruptcy proceedings against the Company;

- da potpiše i na propisanom obrascu podnese prijedlog za otvaranjem stečajnoga postupka nad Društvom koji sadrži podatke za identifikaciju dužnika i podnositelja prijedloga te popis imovine i obveze dužnika;
- to sign and submit, on the prescribed form, a petition for the opening of bankruptcy proceedings against the Company, containing the information required for the identification of the debtor and the applicant, as well as the list of the debtor's assets and liabilities;
- da potpisuje sve druge isprave i odluke, daje izjave i poduzima pred javnim bilježnikom i drugim nadležnim tijelima sve druge zakonite radnje koje budu potrebne u vezi s predmetom ove punomoći, a posebice da u slučaju potrebe postupi po zaključcima Trgovačkog suda u Zagrebu, podnosi i predaje dokumente i priloge prijedlogu, kao i da preuzima zaključke i rješenja te obavlja bilo kakvu komunikaciju sa sudom.
- to sign all other documents and decisions, make statements, and undertake before notaries public and other competent authorities all other lawful actions necessary in connection with the subject matter of this power of attorney, and in particular, where necessary, to act in accordance with the orders and requests of the Commercial Court in Zagreb, to submit and file documents and annexes to the petition, as well as to receive court orders and decisions and conduct any communication with the court.

Punomoćnik se ovlašćuje da imenuje zamjenika koji će imati sva ovlaštenja iz ove punomoći.

The attorney-in-fact is authorised to appoint a substitute who shall have all powers granted under this power of attorney.

Ova punomoć se izdaje uz uvjet da niti jedan nedostatak ili nejasnoća u opisanim ovlaštenjima punomoćnika (koja su navedena primjera radi, a ne kao način ograničavanja djelovanja) neće poništiti radnje punomoćnika ili njezinih zamjenika.

This power of attorney is issued on the condition that no deficiency or ambiguity in the description of the powers granted to the attorney-in-fact (which are listed by way of example and not as a limitation of authority) shall invalidate any actions undertaken by the attorney-in-fact or their substitutes.
